- What's the rush? There's more than 5 years to go on the current lease. This matter has been on the table for 18+ months. Yet we are told yet again to accommodate NOVA Parks that we need to rush this through as their option on 517 Prince expires at the end of this month. That does not appear to have been a very wise negotiation on their part but is hardly a valid reason for them to now try to force our hand without adequate time for review and public involvement.
- It is hard to fathom the suggestion that there has been little public involvement because this is a complicated legal deal. So the public is too dumb to understand? Why can they suddenly today know the deal that is proposed? Why was it okay for details to be on the table and available to the public 18 months ago? While NOVA Parks has submitted their alternative use report, the Park staff has not completed its study for public review and the Commission's adoption. The Water Park facility is a revenue generator for NOVA Parks. As such, it contributes funds for the complete operation of NOVA Parks; the income is not dedicated to its Alexandria facilities. Therefore, the entity NOVA Parks is liable for all of its bonds and loans; the City should not become a party to NOVA Parks debts Any lease should delineate (describe and map) the limits of the parts of the park that NOVA Parks (NOVA) may utilize. In the past NOVA activities have damaged sensitive, unique natural resources on the site; for example, some areas may not tolerate any picnicking use. Articles VI and XIV of the lease need specifics about the limitations and restrictions on NOVA's facilities and operations. To their credit, NVRPA did this a few days later, but it speaks to the fact that people and organizations respond to incentives. Without any reason to modernize the property, we can expect more

Why Do We Need to Buy Immediately?

Since the Prince Street house has been there for 244 years, it can probably wait another couple of months for the public to weigh in.

Coupling the water park decisions with the Prince Street house is already a stretch. Tying them to the same timeline without public comment is worse.

If considered separately, outcomes for the house can be adjusted within the next year.

If not considered, Alexandria will be locked into a declining status quo with the water park for 20 years.
