Re: The Future of Cameron Run Regional Park

Dear Mayor and City Council:

I am writing on behalf of the Townes at Cameron Parke Homeowner's Association regarding our concerns about the proposed future uses of Cameron Run Regional Park. Located adjacent to Cameron Run Regional Park (the "Park"), the Townes at Cameron Parke ("TCP") consists of 229 townhomes.

Suffice it to say we are very interested in the current and future uses and operation of the Park as well as playing a key role in the process of determining its future.

First, we applaud the decision of the City Council at its June 18th meeting deferring consideration of the proposal to extend the lease for 20 years for the Park which is currently held by the Northern Virginia Regional Park Authority ("NVRPA"). NVRPA presently operates the Great Waves waterpark on the site. Given the profound consequences of such a decision not only for TCP, but the City and Eisenhower Valley, deferral was the right decision. We hope the City Council will continue this path of deliberation and consultation with TCP and other interested stakeholders in the City.

Any decision by the City Council regarding the future of the Park should not be tied in any way whatsoever to a separate transaction involving the proposed acquisition by NVRPA of a historical home in Old Town. While the future of the home also is no doubt important, entangling the two distinct and unrelated properties into one transaction puts the City under undue pressure to hastily make a decision regarding the future of the Park before proper stakeholders such as TCP can properly weigh in on it.

A decision of this magnitude should not be rushed.

Unfortunately NVPRA's current operation of the Great Waves waterpark negatively impacts our community. The accumulation of trash in and around the Park, particularly surrounding Lake Cook which abuts our neighborhood, is a persistent problem. The untended land surrounding Lake Cook, overgrown with weeds and suffering from poor lighting, constitutes a nuisance to the TCP. People often use the location as a dumping ground and several times homeless encampments have appeared within the Park creating safety concerns for the community.

Furthermore, during its summer operation, customers using the waterpark park their cars in the TCP, taking up already scarce visitor spots and placing the towing burden on our community.

As one of the only parks in Eisenhower Valley, we believe that the current incarnation of the Park is not the most cost effective or beneficial use of the space for the City and its residents. As the official from NVRPA conceded at the Saturday meeting only 30% of the water park's users are actual City residents. We also do not believe that a waterpark which by its very nature is seasonal is the optimal use for the land.

We also know that as the Eisenhower Valley becomes more residential in nature and its population grows the need for viable green space shall become ever more imperative. To that end, and as means of kicking off the discussion, we suggest that the City consider the following alternatives for improvement for the Park which are not mutually exclusive:

- Year round outdoor playgrounds
- A dog park
- Spray parks and fountains as well as ice skating rinks for winter (Potomac Yard Park and Canal Park in DC are excellent models for such a multi-use park providing water entertainment)
- A pavilion and/or amphitheater
- Space for a restaurant and/or food vendors
- A farmer's market
- Walking trails
- Trees and other plantings to improve the appearance of the Park
- Open fields for families to walk and play around
- Improvements to the Lake Cook area including landscaping in the weed patch and better lighting to discourage dumping and other blight
- A multipurpose recreation center

Regardless of the path ultimately chosen, we believe that the City would prove to be a better steward of the Park than NVRPA and certainly more responsive and accountable to our community and the growing number of residents of Eisenhower Valley and the City's west end.

Finally we request that the City Council institute a formal process for evaluating future uses of the Park including not only TCP, but the Alexandria Department of Recreation, Parks and Cultural Activities, the Eisenhower Partnership, and any of the other local communities and stakeholders with an abiding interest in the future of the Park. This process should include a thorough cost/benefit analysis along with making the Park's future uses environmentally and aesthetically sound.

In sum we think the Park has great potential and that the City Council should use this as an opportunity to expand Alexandria's livability.

We look forward to continuing our dialogue and appreciate your time and consideration of our concerns.
