35	(1) Any person or civic or business association affected by a decision of the
36	director issued pursuant to section 11-513(A)(5) may appeal the decision to the
37	planning commission, by filing a notice of appeal, in writing, stating the grounds
38	on which the person is affected and the grounds of appeal, with the director within
39	30 days of the issuance of the decision.
