

ORDINANCE NO. _____

AN ORDINANCE authorizing the owner of the property located at 530 First Street (parcel address 901 North Saint Asaph Street) to construct and maintain an encroachment for a vault for electric transformers under the sidewalk right of way at that location.

WHEREAS, Giant Alexandria E & A LLC is the Owner (“Owner”) of the property located at 530 First Street (parcel address 901 North Saint Asaph Street) in the City of Alexandria, Virginia; and

WHEREAS, Owner desires to establish and maintain a below-grade vault for electric transformers which will encroach into the public sidewalk right-of-way at that location; and

WHEREAS, the public sidewalk right-of-way at that location will not be significantly impaired by this encroachment; and

WHEREAS, in Encroachment No. 2016-0001 the Planning Commission of the City of Alexandria recommended approval to the City Council subject to certain conditions at one of its regular meetings held on March 1, 2016 which recommendation was approved by the City Council at its public hearing on March 12, 2016 and

WHEREAS, it has been determined by the Council of the City of Alexandria that this encroachment is not detrimental to the public interest; now, therefore,

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Owner be, and the same hereby are, authorized to establish and maintain an encroachment into the public sidewalk right-of-way at 530 First Street (parcel address 901 North Saint Asaph Street) in the City of Alexandria, as shown on the attached Encroachment Plat, said encroachment consisting of a vault for electric transformers under the sidewalk right of way, until the encroachment is removed or destroyed or the authorization to maintain it is terminated by the city; provided, that this authorization to establish and maintain the encroachment shall not be construed to relieve Owner of liability for any negligence on their part on account of or in connection with the encroachment and shall be subject to the provisions set forth below.

Section 2. That the authorization hereby granted to establish and maintain said encroachment shall be subject to and conditioned upon Owner maintaining, at all times and at their own expense, liability insurance, covering both bodily injury and property damage, with a company authorized to transact business in the Commonwealth of Virginia and with minimum limits as follows:

Bodily Injury:	\$1,000,000 each occurrence
	\$1,000,000 aggregate

Property Damage: \$1,000,000 each occurrence
\$1,000,000 aggregate

This liability insurance policy shall identify the City of Alexandria and Owner as named insureds and shall provide for the indemnification of the City of Alexandria and Owner against any and all loss occasioned by the establishment, construction, placement, existence, use or maintenance of the encroachment. Evidence of the policy and any renewal thereof shall be filed with the city attorney's office. Any other provision herein to the contrary notwithstanding, in the event this policy of insurance lapses, is canceled, is not renewed or otherwise ceases to be in force and effect, the authorization herein granted to establish and maintain the encroachment shall, at the option of the city, forthwith and without notice or demand by the city, terminate. In that event, Owner shall, upon notice from the city, remove the encroachment from the public right-of-way, or the city, at its option, may remove the encroachment at the expense and risk of Owner. Nothing in this section shall relieve Owner of their obligations and undertakings required under this ordinance.

Section 3. That the authorization hereby granted to establish and maintain said encroachment shall in addition be subject to and conditioned upon the following terms:

- (a) Neither the City of Alexandria nor any public or private utility company shall be responsible for damage to Owner' or Tenant's property encroaching into the public right-of-way during repair, maintenance or replacement of the public right-of-way or any public facilities or utilities in the area of encroachment.
- (b) The Owner shall be responsible for replacement and repairs to the adjacent City right-of-way, including any areas damaged during construction activity.
- (c) In the event the City shall, in the future, have need for the area of the proposed encroachment, the Owner or Tenant shall remove any structure that encroached into the public right-of-way, within six months, upon notification by the City.
- (d) The applicant shall not be permitted any above ground encroachment in the public right of way, except access panels that must be flush with the sidewalk. The opening of the access panels shall be sized to maintain and replace the transformers and switch gears when needed.
- (e) The underground encroachment shall be limited from 5 feet below grade to the depth needed for installation of transformers and switch gears. The 5 feet below grade depth may be used by the City for landscape or other infrastructure improvements.

1 Section 4. That by accepting the authorization hereby granted to establish and
2 maintain the encroachment and by so establishing and/or maintaining the encroachment, Owner
3 shall be deemed to have promised and agreed to save harmless the City of
4 Alexandria from any and all liability (including attorneys' fees and litigation expenses) arising by
5 reason of the establishment, construction, placement, existence, use or maintenance of the
6 encroachment.

7
8 Section 5. That the authorization herein granted to establish and maintain the
9 encroachment shall be subject to Owner maintaining the area of the encroachment at all times
10 unobstructed and free from accumulation of litter, snow, ice and other potentially dangerous
11 matter.

13 Section 6. That nothing in this ordinance is intended to constitute, or shall be
14 deemed to be, a waiver of sovereign immunity by or on behalf of the City of Alexandria or any
15 of its officers or employees.

17 Section 7. That the authorization herein granted to establish and maintain the
18 encroachment shall be terminated whenever the City of Alexandria desires to use the affected
19 public right-of-way for any purpose whatsoever and, by written notification, demands from
20 Owner the removal of the encroachment. Said removal shall be completed by the date specified
21 in the notice and shall be accomplished by Owner without cost to the city. If Owner cannot be
22 found, or shall fail or neglect to remove the encroachment within the time specified, the city shall
23 have the right to remove the encroachment, at the expense of Owner, and shall not be liable to
24 Owner for any loss or damage to the structure of the encroachment or personal property within
25 the encroachment area, caused by the removal.

27 Section 8. The term "Owner" shall be deemed to include Giant Alexandria E & A
28 LLC and its respective successors in interest.

30 Section 9. That this ordinance shall be effective upon the date and at the time of its
31 final passage.
