That Title 10, Chapter 1, Section 10-1-15.1 of the Code of the City of 14 Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended to read as follows: 15 16 (New language is underscored; deleted material is stricken) 17 18 Sec. 10-1-15.1 Truck traffic; prohibited on certain streets; penalty. 19 (a) Motor trucks are prohibited from using the following streets or portions of streets: 20 (1) Powhatan Street between North Washington Street and Henry Street; 21 (2) South Gordon Street: 22 (3) South Early Street; 23 (4) South Floyd Street: 24 (5) the 200 block of South Fayette Street; 25 (6) the 200 block of South Payne Street; (7) the 600 block of South Saint Asaph Street; 26 27 (8) the 300 and 400 blocks of North Fayette Street; 28 (9) the 300 and 400 blocks of North Payne Street: 29 (10) the 1200 and 1300 blocks of Queen Street; 30 (11) the 1200 and 1300 blocks of Princess Street: 31 (12) the 1200 and 1300 blocks of Oronoco Street; 32 (13) Pickett Street between Seminary Road and Pegram Street; 33 (14) Jordan Street between Seminary Road and Duke Street; 34 (15) Howard Street between Seminary Road and Jordan Street; 35 (16) Richenbacher Avenue between north Van Dorn Street and Pickett Street: 36 (17) Taney Avenue between north Van Dorn Street and Jordan Street; 37 (18) the 300 block of South Henry Street; 38 (19) the 200 block of South West Street between the hours of 11:00 p.m. and 7:00 a.m. only; and 39 (20) West Taylor Run Parkway between Janneys Lane and Duke Street. 40 (21) North Early Street between Menokin Drive and Braddock Road. 41 (22) West Rosemont Avenue between Commonwealth Avenue and Russell Rd 42 (23) West Linden Street between Commonwealth Avenue and Russell Road 43 44 (Subsequent sections remain unchanged.) 45
