WHEREUPON, upon motion by Vice Mayor Wilson, seconded by Councilwoman Pepper and carried 5-0, City Council went into closed executive session to consult with staff and legal counsel regarding threatened or pending litigation and the possible resolution or settlement of such litigation, specifically, threatened litigation involving utility infrastructure and threatened contract litigation for a City owned building, both pursuant to Section 2.2-3711(a)(7) of the Code of Virginia. ORAL REPORTS FROM CITY COUNCIL ON BOARDS, COMMISSIONS AND COMMITTEES

* Patrick Henry Advisory Group (Councilwoman Pepper)

Councilwoman Pepper said the Patrick Henry Advisory Group held its final meeting November 30. She said one of the questions the project team asked was to comment on how it worked for them. She said there was a feeling that things got solved for them, as in site restrictions, terrain, architects, principal, recreation staff and school staff, had played a part of what could and couldn't be done, and the advisory group was a liaison to whatever group they represented. Councilwoman Pepper said one of the things she advocated for was to have dedicated parking for that rec facility.

* Northern Virginia Regional Commission (Councilwoman Pepper and Councilman Bailey)

Councilwoman Pepper said NVRC met December 8, and one of the action items was a resolution authorizing NVRC to accept a grant from the U.S. Department of Transportation Maritime Administration, and it was worded in a way that she was concerned that it might be asking them to support receipt of the grant for \$174,361 on the concept of a fast ferry commuter service, and Alexandria has its own concerns about that. Councilwoman Pepper said she called the acting executive director to find out if it was an endorsement for them and was told it was to be used to be looking for other alternatives and Alexandria would not be one that was on the agenda. Councilwoman Pepper said they had a presentation from an Alexandria resident, demographer Ken Billingsly, who was concerned about the under counting of populations in Northern Virginia by the Weldon Cooper Center. They are working on state and locality population projections for Virginia, so it appears that what they are projecting is a drop in population growth for Northern Virginia in the next decade or so. Weldon is seeking input before provisional release of projections.

* WMATA (Councilman Smedberg)

Councilman Smedberg said the finance committee had the first of three work sessions

where it discussed the capital budget leading up to the introduction of the budget to the public and for the public hearing that will be advertised soon. The capital subcommittee also met and have been working on various issues. He said they have been debating hours and they have some agreement. The general manager and staff put forward a strong argument on the change to the hours, in order to do additional preventative maintenance and get the system in a state of good repair. Councilman Smedberg said it allows the crews to be in for an extended period of time to do the work, and they will reevaluate it after a year.

* Northern Virginia Transportation Commission (Councilman Smedberg)

Councilman Smedberg highlighted that from the last meeting, the Commission passed a resolution in support of the proposal for the Safety Commission that D.C., Maryland and Virginia are working on. The Safety Commission would be established to oversee WMATA. Councilman Smedberg said the District would be the first jurisdiction to pass something, and each jurisdiction has to pass the same exact language.

Councilmember Lovain said they have a deadline they are up against from the FTA that they probably won't make.

BE IT FURTHER RESOLVED, that the PUBLIC BODY will provide funds in the amount of \$60,235, which will be used as a 20 percent match to the state funds in the ratio as required in such Act, that the records of receipts of expenditures of funds granted the PUBLIC BODY may be subject to audit by the DEPARTMENT and by the State Auditor of Public Accounts, and that funds granted to the PUBLIC BODY for defraying the expenses of the PUBLIC BODY shall be used only for such purposes as authorized in the Code of Virginia.

Accounts and those funds granted to the PUBLIC BODY for defraying the expenses of the PUBLIC BODY shall be used only for such purposes as authorized in the <u>Code of Virginia</u>.

WHEREAS, the Industrial Development Authority of the City of Alexandria (the "Authority") has considered the request of PAEGR Properties LLC, a Virginia limited liability company (the "Borrower") whose manager is National Industries for the Blind, a New York non-profit corporation and an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), for modification of the terms of the Authority's \$25,634,834.21 Revenue Bond (National Industries for the Blind Project) Series 2015 (the "Bond"), which was originally issued to assist the Borrower in financing or refinancing certain of the costs of one or more of the following: (i) all or a portion of the acquisition, development (in one or more phases), construction, furnishing and equipping of a new headquarters facility (the "Facility") located or to be located on approximately 19,012 square feet of land within Land Bay G, Potomac Yard Town Center in Alexandria, Virginia; (ii) the acquisition, installation and equipping of furniture, fixtures, equipment and office technology within the Facility and other property functionally related and subordinate thereto; and (iii) certain other eligible expenditures (collectively, the "Project") and has held a public hearing in connection therewith on December 6, 2016;

WHEREAS, the modifications to the Bond requested by the Borrower are expected to cause a deemed current refunding and reissuance of the Bond for federal income tax purposes;

WHEREAS, Section 147(f) of the Code provides that the governmental unit having jurisdiction over the issuer of private activity bonds and over the area in which any facility financed with the proceeds of private activity bonds is located must approve the issuance, including any reissuance, of such bonds:

WHEREAS, the Authority issues its bonds on behalf of the City of Alexandria, Virginia (the "City"), the facilities of the Borrower described above are located in the City, and the City Council of the City (the "Council") constitutes the highest elected governmental unit of the City;

WHEREAS, the Authority has recommended that the Council approve the reissuance of the Bond; and

WHEREAS, a copy of the Authority's resolution approving the modifications to and reissuance of the Bond, a certificate of the public hearing and a Fiscal Impact Statement for the Project have been filed with the Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA, VIRGINIA:

- 1. The Council approves the reissuance of the Bond by the Authority for the benefit of the Borrower, as required by Section 147(f) of the Code and Section 15.2-4906 of the Code of Virginia of 1950, as amended (the "Virginia Code"), to permit the Authority modify the Bond to assist in refunding the Project.
- 2. The approval of the reissuance of the Bond does not constitute an endorsement to a prospective purchaser of the Bond of the creditworthiness of the Bond or the Borrower.
- 3. The modification and reissuance of the Bond as requested by the Borrower will not constitute a debt or pledge of the faith and credit of the Commonwealth of Virginia or the City of Alexandria, Virginia, and neither the faith and credit nor the taxing power of the Commonwealth of Virginia or any political subdivision thereof will be pledged to the payment of the Bond.
- 4. The approval of the reissuance of the Bond contained in this resolution is independent of any other approval or approvals by the Council or the City that may be required in connection with the Project (the "Additional Approvals"), and nothing contained in this resolution shall be construed to imply that any such Additional Approvals will be granted or to bind the Council or the City in any way with respect to any Additional Approvals.

WHEREAS, the Ad Hoc Veterans Commission Advisory Group will conduct specified tasks outlined in this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA, VIRGINIA:

That there is hereby established the Ad Hoc Veterans Commission Advisory Group ("Advisory Group") whose mission is to provide a recommendation to City Council regarding the creation of a permanent Alexandria Veterans Commission ("Commission") that would address the concerns and needs of veterans, service members, their family members and caregivers.

- 1. That the Advisory Group shall consist of seven members, to be appointed by the City Manager, representing a diversity of interests in veterans affairs.
- That the City Manager shall appoint the Advisory Group Chair, whose role is to serve as a meeting facilitator, spokesperson and work with City staff to set Advisory Group meeting agendas.
- 3. That the function of the Advisory Group shall be to discuss and provide guidance to City Council with regards to the development of an Alexandria Veterans Commission. The Advisory Group will assist in the development of a report that shall include comments and recommendations concerning:
 - a. the need for the committee and possible duplications or conflicts with other committees;
 - b. the appropriateness of a committee format to deal with the issues involved;
 - the purview of the Commission through a defined mission, vision and strategies
 to better connect veterans, services members and their family members and
 caregivers to the City;
 - d. the impact that creation of the committee will have on city staff resources, including:
 - (i)the estimated total amount of city staff time that will be required on an annual or other basis to staff the committee:
 - (ii) whether the committee can accomplish its assigned work with existing staff: and
 - (iii)if new staff will be required, the total amount of additional staffing that will be required and the projected annual cost of such additional staff.
 - e. the responsibilities, duties, scope of work, and staffing and funding levels for a permanent Commission;
 - f. the concerns and needs of veterans, services members, their family members and caregivers that will be addressed by the Commission; and
 - g. the composition and term of office for the Commission members.
- 4. That members of the Advisory Group are expected to:
 - Support the City's community engagement and outreach efforts by speaking on behalf of their representative groups and communicating their interests in this process.
 - b. Attend and participate fully in all Advisory Group meetings, in addition to attending work sessions and public hearings of the City Council as needed. If unable to attend, members are encouraged to notify staff in advance and provide comments on meeting materials in a timely manner.

- 5. That the Advisory Group will be staffed by a representative appointed by the City Manager as dictated by available staff resources and the nature of the work.
- 6. That to assure compliance with City Code Section 2-4-8(c) 2-3, the Advisory Group shall develop an inventory of federal, state and non-profit organizations that provide services to veterans, services members, their family members and caregivers that are available to Alexandria residents.
- 7. That pursuant to City Code Section 2-4-8, the Advisory Group shall meet on an ad hoc basis as needed for the period of 3 months, with up to an additional 2 months if needed for completion of their stated tasks as defined herein, unless otherwise extended by City Council.
