25. Consideration of the Cameron Run Park Public Planning Process to Identify Potential Alternative Future Use(s) of the Cameron Run Regional Park Site.

Mr. Spengler, Director, Recreation, Parks and Cultural Activities, and Mr. Browand, Deputy Director, Recreation, Parks and Cultural Activities, made a presentation of the report and they, along with Mr. Jinks, City Manager, responded to questions of City Council.

WHEREUPON, upon motion by Councilmember Lovain, seconded by Councilwoman Pepper and carried unanimously, City Council: 1. endorsed the proposed Cameron Run Park Public Planning process subject to remarks made from the dais; and 2. authorized the City Manager to direct the Department of Recreation, Parks and Cultural Activities to proceed with the proposed planning process, with the understanding that the planning process is aimed at recreational uses only. - 2. Mayor Silberberg said the Swedish Delegation from Helsingborg, Sweden, one of four of the City's sister cities, were in the City, and she thanked those who helped make the trip a success.
- 3. Mayor Silberberg mentioned the threat of snow the other day and the City's snow buddies program where volunteers can help clear snow for citizens. She encouraged people to plan in advance if a storm is coming by moving cars to garages to get them off the streets.
- 4. Councilwoman Pepper said an announcement came out that the Boys and Girls Club are having their annual fundraiser on February 10. It is a reception, dinner and silent auction at the Carlyle Club and is \$125 per person and \$200 per couple. She said they are honoring the Honorable Tim Kaine. Councilwoman Pepper said the honorary benefit chair is Frank Fannon.
- 5. Councilwoman Pepper said the Martin Luther King, Jr. annual community event will be held on January 15 at 7:30 at the Church of St. Clement on Quaker Lane.

Mayor Silberberg said there will be a Martin Luther King, Jr. City employee event on Thursday at noon at the Lee Center.

6. Vice Mayor Wilson spoke of an email he sent to Council yesterday about the impact the public comment has on the public hearing dockets. He said he looked at the City's resolution, which has a solution, which is to limit the public comment to 30 minutes and then that after the 30 minutes the additional public comments be rolled to the end of the meeting, in order to get the public comment on the other docketed items as well. He suggested that the first 10 speakers be given the opportunity to speak at the beginning of the meeting and the rest would be at the end of the docket.

Councilman Smedberg also suggested that Council adhere to the long-standing policy of sending notice or emails 24 hours in advance if something is going to be brought up under

oral reports or proposed during the meeting, so that it is clearly outlined and is a much more logical, respectful way to introduce new ideas.

There was discussion among City Council about the public comment period, the length of meetings and public discussion period times, engaging speakers, having a public hearing on the recommendation, managing public hearing comments, and expanding the public discussion time to one hour versus the number of speakers.

WHEREUPON, upon motion by Vice Mayor Wilson, seconded by Councilman Bailey and carried 6-1, City Council moved to direct the City Clerk that the first 15 speakers on public discussion will be allowed to go on public comment and that any beyond 15 will be heard at the end of the agenda.
