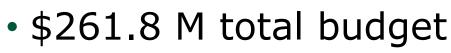

FY 2018 Major Budget Pressures

- School Operating and Capital (1/24 Meeting)

- Presentation of City Proposed Budget and Capital Improvement Program (2/21 Meeting)

ACPS Superintendent's Proposed Operating Budget



- \$8.4 M increase over FY 2017 (+3.3%)
- \$216.1 M proposed City operating transfer¹
 - \$9.6 M increase over FY 2017 (+4.6%)
 - Equals 78.8% of <u>all</u> projected General Fund revenue increases

¹Excludes School related debt service increase of approximately \$4.1 M.



General Fund Estimates

- Current Revenue Estimate = +\$12.2 M (1.8%)
- Operating Expenditure Pressures
 - Metro = +\$6.5 M (20.0%)
 - ACPS Operating = +9.6 M (4.6%)
 - City Operating = TBD
 - ACPS and City Capital = TBD

ACPS Superintendent's Proposed Operating Fund Expenditures



- \$8.4 M increase (+3.3%)
 - Personnel +\$10.4 M (4.7%)
 - Lease costs -\$2.5 M (-100.0%)
 - Other Non-Personnel +\$0.5 M (1.7%)
- Major cost drivers
 - 22.27 Net FTE increase
 - Enrollment increase of 225 students¹
 - Employee compensation
 - Department reductions
 - Priority additions
