

Summary

- New 2.5-bay fire station built on existing site
- Site and building accommodate two drivethrough bays for modern fire apparatus vehicles
- Building will be red brick and reflect neighborhood architectural character
- Increased landscaping and plantings in the three front yards of the site and bioretention "rain garden"



Special Use Permits

- Special Use Permit to intensify/expand the existing noncomplying fire station
- Special Use Permit for a parking reduction of 10 spaces

Modifications

- Modification to allow an accessory structure forward of the front building line
- Modification to the side yard ۲ setback to allow for the placement of a generator

Parking

Required	24 spaces (1 space per 450 square feet of governmental office in Parking District 2)	
Proposed (on-site)	14 spaces	
Reduction	10 spaces	

• The parking area will accommodate the maximum number of staff on shift, including during shift change

Construction and Temporary Street Closure

Temporary Station and Street Closure Impact Mitigation

- City staff will work with project architect to procure temporary apparatus bays that mitigate noise and visual impacts to extent possible.
- The Fire Department is coordinating with ACPS to facilitate pickup of children on Pierpont Street during construction with a van or small bus.

Construction Impact Mitigation

- Construction workers are required to park on-site by Condition of Approval (Condition 33)
- Sidewalk on east side of Pierpont Street will remain open during construction (Condition 34)
- The current curb cut on Monticello Blvd. will be used as primary construction entrance
- Construction times and noise will be regulated by City codes (T&ES Code Comment C-10)
