Attached (via hyperlink, noted as Attachment 1) you will find the Proposed FY 2018 - FY 2027 Capital Improvement Program (CIP) for review at your April 6, 2017 meeting. The Planning Commission is requested to review the proposed capital improvement projects with regard to the consistency of these proposed projects with the City's master plan. This is pursuant to Section 6.14 of the City Charter, which states "the City Manager shall obtain and transmit to the Council the advisory recommendations of the Planning Commission with regard to the consistency of proposed capital improvement projects with the master plan and the priority and timing of those projects in comparison to the elements in the master plan."

Subsequent to the City Manager's release of the Proposed Operating and Capital Budgets on February 21, 2017, a work session was held on March 1, 2017 to begin City Council's deliberation of the CIP. Additional CIP discussions took place as part of the "Livable, Green, & Prospering City" budget work session on March 21, 2017. An additional work session to discuss Alexandria City Public Schools' CIP and Operating Budget occurred on March 8, 2017. Budget memoranda will be provided as completed on operating and capital budget issues. The results of the Commission's review are requested prior to the add/delete work session of City Council, which is scheduled for April 25, 2017.
