1 ORDINANCE NO. 2 3 AN ORDINANCE to amend and reordain Section 10-4-8 (PARKING FOR MORE THAN 4 72 CONTINUOUS HOURS) of Chapter 4 (STOPPING, STANDING AND PARKING) of 5 Title 10 (MOTOR VEHICLES AND TRAFFIC) of the Code of the City of Alexandria, 6 Virginia, 1981, as amended. 7 8 THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS: 9 10 Section 1. That Title 10, Chapter 4, Section 10-4-8 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended by adding the 11 12 language shown as underlined: 13 14 Sec. 10-4-8 - Parking for more than 72 continuous hours. 15 Unless otherwise controlled by an official sign, the parking of any vehicle in the same place 16 on the streets of the City for more than 72 hours is prohibited; provided that this prohibition shall 17 not apply to the parking of a vehicle in the same place on the streets of the City on Saturday, Sunday and holidays, or any vehicle granted a 72-hour parking rule exemption as provided in 18 19 subsection 10-4-8 (a). 20 (a) Exemption. A 72-hour parking rule exemption may be provided to residents by the Alexandria Police Department in coordination with the Department of Transportation and 21 Environmental Services pursuant to the regulations detailed in 10-4-8 (b). If granted, a 72-hour 22 parking rule exemption will not supersede any posted signage. All hourly restrictions otherwise 23 applicable to a parked vehicle remain subject to enforcement. The provisions of subsections 10-4-24 25 8 (a) and 10-4-8 (b) shall expire on November 1, 2018. (b) Exemption regulations. 26 27 (1) Exemptions shall only be granted to vehicles registered with the City of Alexandria. 28 (2) Exemptions may not be transferred between vehicles. 29 Each exemption may be granted for a maximum of two weeks. (3) 30 Vehicles may be granted a maximum of four exemptions per year. (4) 31 (5) Vehicles may be granted no more than two contiguous exemptions. 32 (6) Vehicles will only be permitted to park within one-eighth mile of their place of 33 residence. Vehicles granted exemptions found parking beyond this maximum radius will be subject to enforcement. 34 35 The Department of Transportation and Environmental Services and the Alexandria (7) 36 Police Department retain the right to move and store vehicles when necessary due to

street maintenance, in cases of emergency, or as otherwise provided by law.
