Mayor Silberberg called the meeting to order and the City Clerk called the roll. All members of City Council were present. (Councilman Smedberg joined Council in closed meeting.)

* METRO (Councilman Smedberg)

Councilman Smedberg said there is a meeting on Thursday and noted that there is a lot

of discussion on the general manager's report on his ideas about financing and moving Metro forward.

* Virginia Railway Express (Councilman Smedberg)

Councilman Smedberg said that VRE will celebrate its 25th year in Fredericksburg in June, and the Governor, transportation secretary and others will be there. He said there will be a train naming ceremony in Burke on Saturday, which he will not be able to attend.

* NVTC (Councilmember Lovain)

Councilmember Lovain said neither he or Councilman Smedberg were able to go to the NVTC meeting, but there was a discussion about financing Metro and the discussion of the one percent sales tax for the region, but the problem is that Metro is divided equally between Virginia, Maryland and D.C., but Virginia accounts for more population than D.C. and Maryland combined. So if a one percent sales tax is done across the board, Virginia is a huge subsidy of the other jurisdictions, so there would have to be a different kind of financing for it to work.

* Region Forward Coalition

Councilmember Lovain said they had an interesting meeting in Crystal City and had 14 electives there. One issue was office building repositioning and repurposing, and Fairfax County related that it had 19 million square feet of vacant office space, and they spoke of the things that can be done to repurpose the buildings. Councilmember Lovain said it had a discussion on workforce development and increased opportunities for middle-scale employees – people who need more than a high school diploma but less than a college degree. There are 160,000 people in the D.C. area that are in that category. Half of all workers in the region work in a jurisdiction other than the one that they live in. He said the most interesting thing was a presentation by the Crystal City BID and they do pop-up beer gardens, yoga classes, do a 5K every Friday in April, bike races, repurposing of vacant space, mini libraries and art spaces. Councilmember Lovain said he asked what is in it for offices, and they said that a lot of the offices are people who have customers – dentists, accountants, and their customers will come around more often if they have shops and restaurants nearby. He said the BID revitalized the Crystal City area.

Mayor Silberberg said she was honored to join alumni from George Washington High School over the weekend, which existed from 1935 to 1971, and the alumni put together a box of material digitizing their yearbooks, photos and minutes, and it will be presented to Mr. Mallamo of the Office of Historic Alexandria.

5. Councilman Bailey said today is teacher appreciation day, a day for honoring teachers and recognizing the lasting contributions they have made in our lives. He thanked teachers for what they do each and every day for their kids.

6. Councilman Bailey said this is National Police Week, which honors all fallen officers, which includes both Police and Sheriff's.

7. Mayor Silberberg said that yesterday was the annual wreath laying at the Police Department Memorial and it honors the 18 who have died in the line of duty, and their hearts and thoughts go to all the families of those who have fallen.
