Many of the youth Mr. Armstrong coached and mentored went on to be productive citizens in Alexandria and throughout the metropolitan area. For eight years, Mr. Armstrong served as the Commissioner of the Johnson-Siebert Summer Adult Basketball League that served hundreds of young adults. In addition, his commitment to building youth through athletics earned Mr. Armstrong the 2005 Mid-Atlantic Recreation & Parks' Sports Alliance's Sportsmanship Award.

"Cora Kelly Recreation Center was named for its proximity to the Cora Kelly School, rather than named directly for Cora Lee Webster Kelly, a beloved Alexandria teacher. The City Council Naming Committee will consider whether to name the recreation center after a person for the first time. The name of the school would remain unchanged."

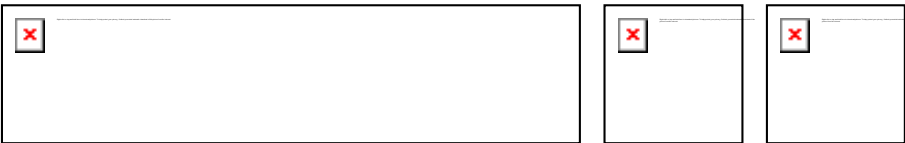
