4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
5	adopting and incorporating therein the amendment heretofore approved by City Council to
6	replace the Old Town North Small Area Plan Chapter of such master plan with an updated
7	small area plan including the Old Town North Urban Design Standards and Guidelines as
8	Master Plan Amendment No. 2017-0002 and no other amendments, and to repeal all
9	provisions of the said master plan as may be inconsistent with such amendment.

11	WHEREAS, the City Council of the City of Alexandria finds and determines that:

13	1. In Master Plan Amendment No. 2017-0002, the Planning Commission, having
14	found that the public necessity, convenience, general welfare and good zoning practice so
15	require, recommended approval to the City Council on June 14, 2017 of an amendment to the
16	Master Plan of the City of Alexandria to replace the Old Town North Small Area Plan Chapter
17	with an updated small area plan that includes the Old Town North Urban Design Standards and
18	Guidelines, which recommendation was approved by the City Council at public hearing on June
19	24, 2017;

21	2. The said amendment has heretofore been approved by the planning commission
22	and city council after full opportunity for comment and public hearing.

24	3. All requirements of law precedent to the adoption of this ordinance have been
