11 12 13 14	Section 1. That Title 2, Chapter 4, Article 1, Section 2-4-80 of The Code of the City of Alexandria, Virginia, 1981, as amended, be, and same hereby is amended by deleting the sections shown in strikethrough and adding the language shown as underlined:
15 16	ARTICLE I - Alexandria Archaeological Commission
17 18	Sec. 2-4-80 - Creation, composition and organization.
19 20 21	(a) There is hereby established a standing commission known as the Alexandria Archaeological Commission.
22 23 24	(b) The commission shall consist of 15 members to be appointed by the city council. The composition of the commission shall be as follows:
25 26	(1) five members at large;
27 28	(2) one citizen member from each of the three planning districts;
29 30	(3) one member from the Alexandria Association;
31 32	(4) one member from the Alexandria Chamber of Commerce business community;
33 34	(5) one member from the Alexandria Convention and Visitors Bureau Board of Directors;
35 36	(6) one member from the Alexandria Historical Society;
37 38	(7) one member from the Alexandria Society for the Preservation of Black Heritage;
39 40	(8) one member from the Friends of Alexandria Archaeology; and
41 42	(9) one member from the Historic Alexandria Foundation.
43 44	(c) Members of the commission shall be appointed in the manner prescribed in title 2, chapter 4, article A of the city code; provided that members who are the representative of an organization
45 46	shall be nominated by the organization and confirmed by city council. The members shall serve for a term of four years; provided, that the members of the commission in office as of January

1	21, 1995, shall continue to serve the unexpired portion of their term of office; and, provided
2	further, that the members who are the representative of an organization shall cease to be a
3	member at such time as they shall cease to be a member, in good standing, of the organization
4	for which they serve as representative.

6	Section 2. That Section 2-4-80, as amended pursuant to Section 1 of this ordinance,
7	be, and the same hereby is, reordained as part of the Code of the City of Alexandria.
8	
9	Section 3. That this ordinance shall become effective on the date and time of its final
10	passage.
