10	Section 1. That Title 2, Chapter 4, Article 1, Section 2-4-80 of The Code of the City

13	sections shown in strikethrough and adding the language shown as underlined:

19	(a) There is hereby established a standing commission known as the Alexandria Archaeological
20	Commission.
21	(b) The commission shall consist of 15 members to be engointed by the sity council. The

42 43	(c) Members of the commission shall be appointed in the manner prescribed in title 2, chapter 4,
44	article A of the city code; provided that members who are the representative of an organization
45	shall be nominated by the organization and confirmed by city council. The members shall serve
46	for a term of four years; provided, that the members of the commission in office as of January

1	21, 1995, shall continue to serve the unexpired portion of their term of office; and, provided
2	further, that the members who are the representative of an organization shall cease to be a
3	member at such time as they shall cease to be a member, in good standing, of the organization
4	for which they serve as representative.

6	Section 2. That Section 2-4-80, as amended pursuant to Section 1 of this ordinance,
7	be, and the same hereby is, reordained as part of the Code of the City of Alexandria.
