22	of the water meter size to account for the change in use under the following schedule:

24	i) applicants are responsible for 50 percent of the increased fee if the final site plan is approved,
25	or if such site plan is not required, the building permit is granted, prior to June 30, 2018;

27	ii) applicants are responsible for 75 percent of the increased fee if the final site plan is
28	approved, or if such site plan is not required, the building permit is granted, prior to June 30,
