The IDA is organized pursuant to State legislation and is strictly subject to its own State-level enabling legislation; appointees to the IDA are local appointees but all of the IDA's strictures are established in state (and to some extent Federal tax) law. The IDA's role is purely to act as a nominal bond issuer, and does not conduct any regulatory, custodial, or other duties. Essentially every IDA transaction involves direct interaction with lenders and/or underwriters, and new issuances of financings generally require the conduct of TEFRA notice proceedings under the Internal Revenue Code. The IDA's activities are closely coordinated with, and support, the activities of AEDP.

State law fixes the IDA's membership at exactly seven, requires the imposition of staggered terms, and fixes the requirements for IDA appointments. The City cannot expand the IDA's membership.

At present, the only commercial banker in active employ on the IDA is Chris Hartman, who also chairs AEDP. The IDA benefits from his membership, and his background on the IDA is presently unique. I ask that City Council take these facts, and the specialized nature of the IDA's financial functions, into account in its October 10 vote.
