4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
5	adopting and incorporating therein the amendment approved by city council on January 20,
6	2018 to the Beauregard chapter of such master plan as Master Plan Amendment No. 2017-
7	0008 and no other amendments, and to repeal all provisions of the said master plan as may
8	be inconsistent with such amendment.
9	
10	WHEREAS, the City Council of the City of Alexandria finds and determines that:
11	
12	1. In Master Plan Amendment No. 2017-0008, the Planning Commission, having
13	found that the public necessity, convenience, general welfare and good zoning practice so
14	require, recommended approval to the City Council on January 4, 2018 of an amendment to the
15	Beauregard Chapter of the Master Plan of the City of Alexandria to change the land use
16	designation of the property located at 2280 N. Beauregard Street from Senior Housing to
17	residential, which recommendation was approved by the City Council at public hearing on
18	January 20, 2018;

20	2. The said amendment has heretofore been approved by the planning commission
21	and city council after full opportunity for comment and public hearing.

23	3. All requirements of law precedent to the adoption of this ordinance have been
24	complied with; now, therefore,

26	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
27	Section 1. That the Decumerand Charten of the Master Dian of the City of

29 30	Alexandria, be, and the same hereby is, amended to revise the land use designation on the
30 31	property located at 2280 N. Beauregard Street from senior housing to residential on Map #23 and Map #25 of the Beauregard Chapter as shown in the map that is attached hereto and incorporated
32	fully herein by reference.

34	Section 2. That the director of planning and zoning be, and hereby is, directed to
35	record the foregoing master plan amendment as part of the Master Plan of the City of
36	Alexandria, Virginia.

38	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,
39	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.

42	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,

3	Circuit Court shall file same among the court records.
