1. Calling the Roll.

Mayor Silberberg called the meeting to order and the City Clerk called the roll. All the members of Council were present.

2. Moment of Silence and Pledge of Allegiance.

City Council participated in a moment of silence and recited the Pledge of Allegiance.

3. Reading and Acting Upon the Minutes of the Following Meetings of City Council:

The Regular Meeting Minutes of November 14, 2017.

WHEREUPON, upon motion by Vice Mayor Wilson, seconded by Councilman Smedberg and carried unanimously, City Council approved the regular meeting minutes of November 14, 2017. The vote was as follows: In favor, Mayor Silberberg, Vice Mayor Wilson, Councilman Bailey, Councilman Chapman, Councilmember Lovain, Councilwoman Pepper and Councilman Smedberg; Opposed, none.

PROCLAMATIONS

4. Presentation of a Proclamation Recognizing December 31, 2017, as Fair Weather Night for First Night Alexandria.

WHEREUPON, upon motion by Councilman Chapman, seconded by Councilman Bailey and carried unanimously, City Council endorsed the proclamation. The vote was as follows: In favor, Mayor Silberberg, Vice Mayor Wilson, Councilman Bailey, Councilman Chapman, Councilmember Lovain, Councilwoman Pepper, and Councilman Smedberg; Opposed, none.

5. Presentation of a Proclamation Honoring First Responding Organizations to the June 14, 2017 Simpson Stadium Incident.

WHEREUPON, upon motion by Councilman Chapman, seconded by Councilman Bailey and carried unanimously, City Council endorsed the proclamation. The vote was as follows: In favor, Mayor Silberberg, Vice Mayor Wilson, Councilman Bailey, Councilman Chapman, Councilmember Lovain, Councilwoman Pepper, and Councilman Smedberg; Opposed, none.

ORAL REPORTS FROM CITY COUNCIL ON BOARDS, COMMISSIONS, AND COMMITTEES

Washington Metropolitan Area Transit Authority (WMATA) (Councilman Smedberg)

Councilman Smedberg reported that there was a budget discussion regarding the new budget for WMATA and closing the 2017 Operating budget. Councilman Smedberg also stated that Pensions Subcommittee released data and the Metro Vital Signs report was introduced at the meeting.

Virginia Railway Express (VRE) (Councilman Smedberg)

Councilman Smedberg reported that the Board approved and authorized distribution of the VRE Comprehensive Annual Report. Councilman Smedberg also noted that the audit received the highest rating for a financial audit. Councilman Smedberg reported that VRE approved the submission to NVRA for fund consideration for FY18-FY23 six-year program, which includes ten projects focused on improvements in function at stations, trains, tracks and infrastructure.

Northern Virginia Transportation Commission (NVTC) (Councilman Smedberg)

Councilman Smedberg reported that Secretary LaHood has released the final report on WMATA with a copy of a legal opinion letter from DLA Piper, LLP, endorsing WMATA operating under a reform board. Councilman Smedberg noted that Congresswoman Barbara Comstock released a bill on metro reform, which would move it toward a reform board tied to funding that would increase over time.

Councilmember Lovain reported that action on the I-66 tolls was deferred until the next meeting. Councilmember Lovain stated that the average toll was less than the projected \$17 average in the first few days.

Northern Virginia Regional Commission (NVRC)(Councilman Bailey and Councilwoman Pepper)

Councilwoman Pepper reported that Mark Webb, Chief Legal Counsel and Senior Vice President of Dominion Power, gave a presentation about greening the power grid through partnerships with various renewable energy mechanisms. Councilwoman Pepper stated that street lights with LED lights was discussed. Councilwoman Pepper also reported that there was a resolution adopted opposing the elimination of the State and Local tax deduction as part of the Congressional Tax reform bill that was being proposed.

Transportation Commission (Councilmember Lovain)

Councilmember Lovain reported that the Transportation Commission endorsed the Vision Zero Action Plan, held a public hearing and endorsed the Commercial Parking Standards at the last meeting.

Environmental Action Plan Steering Committee (Councilman Chapman and Councilwoman Pepper)

Councilman Chapman reported that the committed discussed the update of the environmental action plan and the green inventory, noting that the first phase of the environmental action plan update will focus on five areas and has been released for feedback. Councilwoman Pepper stated that this update is the first one since 2009 and she noted that the final draft of phase one will be presented to Council in May.

ORAL REPORT FROM THE CITY MANAGER

City Manager Jinks reported on the improvements at the King-Quaker-Braddock Intersection, noting the goals of the project was to improve safety of all uses and reduce the clutter at the intersection and improve operations and emergency readiness of the intersection. City Manager Jinks also reported that improvements included the installation of mast arms for lane designation, improved pedestrian signals, new signage and pavement markings, and thermal video vehicle detection, reduction of cost for the improvement by \$6 million dollars and the installation of hydrogen power fuel cell battery backup system. City Manager Jinks noted that the results of all the improvements has created a smarter and safer intersection for all users, reduced traffic delays during peak hours, and the service road improvements have eliminated pedestrian conflicts and the potential for rear-end crashes on Quaker Lane. City Manager Jinks reported that the City refinanced \$36 million dollars of bond debt last week, saving the City \$3 million dollars and he noted that the pending federal tax legislation may limit certain future bond refinancing. City Manager Jinks noted that the transaction was completed before the Treasury State and Local Government Series (SLGs) window closed and the City was able to refinance at an interest rate of 1.9% over the 15-year life of the bonds. City Manager Jinks announced that Hillary Orr has been promoted to Deputy Director of Transportation and Transit with Transportation and Environmental Services and Khattab Shammout was hired as the Deputy Director of Right-of-Way and Development Services with Transportation and Environmental Services.

WHEREAS, the City Council wishes to make these changes to the Virginia Department of Transportation road inventory in order to qualify for maintenance payments under the new quarterly payment rates per lane mile for Primary/Minor Arterial and Collector/Local streets respectively, starting as of July 1, 2018; and

NOW, THEREFORE, BE IT RESOLVED that the Alexandria City Council requests that portions of the following roadways be added to the Virginia Department of Transportation Urban Maintenance Inventory.

The resolution reads as follows:

RESOLUTION NO. 2801

WHEREAS, the Industrial Development Authority of the City of Alexandria (the "Authority") has considered the application of American Academy of Otolaryngology – Head and Neck Surgery Foundation, Inc. (the "Borrower"), a corporation which is described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("Code"), requesting the issuance of the Authority's revenue bonds in an amount not to exceed \$8,350,000 (the "2017 Bonds") to assist the Borrower in (a) refunding all or a portion of the Authority's outstanding Headquarters Facilities Revenue Bonds (American Academy of Otolaryngology – Head and Neck Surgery Foundation, Inc.), Series 2008A (Taxable) and Series 2008B (Tax-Exempt) (the "2008 Bonds") which were issued for the purpose of financing or refinancing certain costs of (i) the acquisition, development, construction, renovation and equipping of an approximately 28,000 square foot five story office building located at 1650 Diagonal Road in the City of Alexandria and the acquisition of a parking lot located at 100 Daingerfield Street in the City of Alexandria, (ii) minor improvements to the Borrower's former headquarters facilities located at One Prince Street in the City of Alexandria, along with leasing commissions, moving costs and other related costs and (iii) the issuance of the 2008 Bonds, letter of credit or other credit enhancement costs, capitalized interest, working capital and other eligible expenditures; (b) funding swap breakage costs in connection with the refunding of the 2008 Bonds; and (c) funding certain costs of issuance of the 2017 Bonds (collectively, the "Project") and has held a public hearing in connection therewith on December 5, 2017;

WHEREAS, Section 147(f) of the Code provides that the governmental unit having jurisdiction over the issuer of private activity bonds and over the area in which any facility

financed with the proceeds of private activity bonds is located must approve the issuance of such bonds:

WHEREAS, the Authority issues its bonds on behalf of the City of Alexandria, Virginia (the "City"), the facilities of the Borrower described above are located in the City and the City Council of the City (the "Council") constitutes the highest elected governmental unit of the City;

WHEREAS, the Authority has recommended that the Council approve the issuance of the 2017 Bonds; and

WHEREAS, a copy of the Authority's resolution approving the issuance of the 2017 Bonds, subject to the terms to be agreed upon, a certificate of the public hearing and a Fiscal Impact Statement have been filed with the Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA, VIRGINIA:

- 1. The Council approves the issuance of the 2017 Bonds by the Authority for the benefit of the Borrower, as required by Section 147(f) of the Code and Section I5.2-4906 of the Code of Virginia of 1950, as amended (the "Virginia Code"), to permit the Authority to assist in the financing of the Project.
- 2. The approval of the issuance of the 2017 Bonds does not constitute an endorsement to a prospective purchaser of the 2017 Bonds or the creditworthiness of the 2017 Bonds or the Borrower.
- 3. The issuance of revenue bonds as requested by the Borrower will not constitute a debt or pledge of the faith and credit of the Commonwealth of Virginia or the City of Alexandria, Virginia, and neither the faith and credit nor the taxing power of the Commonwealth of Virginia or any political subdivision thereof will be pledged to the payment of the 2017 Bonds. Neither the City of Alexandria, Virginia nor the Authority shall be obligated to pay the 2017 Bonds or the interest thereon or other costs incident thereto except from the revenues and money pledged therefor.
- 4. This resolution shall take effect immediately upon its adoption.

- 3. Councilman Chapman congratulated City Manager Jinks on receiving the Institute for Regional Excellence Leadership Award as the 2017 Inspiring Leader from the Council of Governments in October.
- 4. Mayor Silberberg reported that the Annual Scottish Christmas Walk was a tremendous success and she thanked Lord Provost and Lady Provost Borthwick from Dundee, Scotland for attending the festivities. Mayor Silberberg thanked the Sister Cities Committee for all their hard work during the weekend's event. Mayor Silberberg noted that the Campagna Center coordinated many volunteers to staff the events of the weekend and they raised money for the programs they sponsor to support children in the community.

- 5. Mayor Silberberg reported that the 16th Annual Alexandria Holiday Boat Parade of Lights was held last Saturday night and she noted that USA Today ranked the parade eighth among the best holiday parades in the country.
- 6. Mayor Silberberg reported that Neighborhood Health, Inc., held its 20th Anniversary Celebration Gala on Thursday night and she thanked all the volunteers who have served with the organization through the years.
- 7. Mayor Silberberg reported on the Smart 911 system and encouraged all residents and visitors to enroll in the program. Mayor Silberberg gave a detailed description of the Smart 911 system and noted that residents can enroll via the City's website. Mayor Silberberg reported that the system allows residents to enroll themselves, anyone who lives in their home, pets, and to include medical information, as well as home and work contact information, into the highly secured system to help dispatchers during an emergency call.
