1. Calling the Roll.

Mayor Silberberg called the meeting to order and the City Clerk called the roll. All the members of Council were present, with Councilman Chapman and Councilwoman Pepper arriving during the closed executive session.

2. Closed Meeting.

**WHEREUPON**, upon motion by Vice Mayor Wilson, seconded by Councilman Smedberg and carried 5-0, City Council convened in closed executive session at 6:02 p.m., to discuss or consider the acquisition or disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position of the public body and to discuss with legal counsel and staff actual or probable litigation and specific legal matters requiring the provision of legal advice; specifically, the possible disposition of publicly held real property in support of an environmental infrastructure project and the possible settlement of probable litigation related to specific project involving publicly held real property

and energy infrastructure improvements; pursuant to Sections 2.2-3711(A)(3), (7) and (8) of the Code of Virginia. ## **ORAL REPORTS FROM CITY COUNCIL ON BOARDS, COMMISSIONS, AND COMMITTEES**

### **\*Climate Energy and Environment Policy Committee (Councilwoman Pepper)**

Councilwoman Pepper reported that the Climate Energy and Environment Policy Committee (CEEPC) had presentation by local governments and universities shifting to investing with companies that were environmentally friendly with pension funds and other investment activities. Councilwoman Pepper requested information from City staff on the

City's investment activities and noted that this practice cause some tension. Councilwoman Pepper also reported that the greenhouse gas inventory for the region has been completed and there is a slight increase for the region from 2012 to 2015 due to the fact that weather was colder and more fuel was used during the winter, as well as other factors. Councilwoman Pepper noted that there was report in the Washington Post about changes of EPA regulations that will revoke Obama era standards changing mileage per gallon for cars. City Manager Jinks noted that the pension boards make a wide range of decisions for investments and social investments have not been a part of the process but they will be review process.

**\*Potomac Yard Metrorail Implementation Work Group (Vice Mayor Wilson and Councilman Smedberg)**

Vice Mayor Wilson reported that Potomac Yard Metrorail Implementation Work Group (PYMIG) held a community meeting and discussed updates about the budget requirements as a result of the procurement process, updates to the schedule and planning process as it relates to the special use permit and amendments coming to City Council by the end of 2018, aiming for a scheduled opening of the station by the late 2012 or early 2022. Vice Mayor Wilson noted that there will be more information forthcoming as we continue the process.

Councilman Smedberg stated that the Governor released some amendments relating to the Omnibus Transportation Bill reviewing the current proposal with possible tax increases to lessen the money coming from local funds to about \$10 million.

**ORAL REPORT FROM THE CITY MANAGER**

City Manager Jinks reported that the Department of Emergency Communications has become the 7th department in the country to attain accreditation and he congratulated the department staff. City Manager Jinks also noted that Renee Gordon, Director, Emergency Communications, has been elected president of the mid-eastern chapter of the Association of Public Safety Communication Officials. City Manager Jinks announced that Kevin Greenlief, Assistant Director, Finance, received the 2018 Leadership Fairfax Katherine "Kate" Hanley Public Servant of the Year Award. City Manager Jinks reported that Smart Growth America selected the City's King Street Project (from King Street to Janney's Lane) as one of the best Complete Street projects in the nation.

4. Recognize the Ad Hoc Combined Sewer System Plan Stakeholder Group and thank them for their efforts in providing valuable input during the development of the plan update and their outreach to the civic groups they represented; and
5. Authorize the City Manager to make any appropriate technical or non-substantive changes and submit the Final LTCPU document to the Virginia Department of Environmental Quality.

**WHEREUPON**, upon motion by Councilman Smedberg, seconded by Vice Mayor Wilson and carried unanimously, City Council: (1) adopted the revised project budget for the Potomac Yard Metrorail Station of \$320 million; (2) authorized the City Manager to sign the Amended and Restated Agreement between the Washington Metropolitan Area Transit Authority (WMATA) and the City for the funding of the Potomac Yard Station Project. (The funding agreement amount is \$290 million which represents the WMATA portion of the revised estimated project budget of \$320 million) consistent with the terms in the stated in the docket memorandum; (3) directed the City Manager to bring an ordinance forward in May, to be considered if the City Council endorses Dominion Energy's alignment of the 230kV line on the same docket, to add a provision to the Tier II Potomac Yard Metrorail Station Special Services District that would sunset the Special Tax District when the Potomac Avenue alignment of the 230kV line is approved; and (4) directed the City Manager to negotiate, consistent with the terms described herein, an amended Memorandum of Understanding related to the developer contributions with the owner of the North Potomac Yard property, subject to future City Council approval. ## **ORAL REPORTS AND ORAL PRESENTATIONS BY MEMBERS OF CITY COUNCIL**

1. Mayor Silberberg requested that a line be added to the Boards and Commissions applications stating that current members of Council could not be used as a reference for applicants. City Council had a discussion on the need to change the form and the use of Council members as references.

**WHEREUPON**, upon motion by Councilman Smedberg, seconded by Councilwoman Pepper and carried 5-1, City Council passed a motion requesting the City Clerk to update the Personal Data Form for Boards and Commission to include a sentence under the reference section stating that applicants cannot list current members of Council or City staff as references. The vote was as follows: In favor, Mayor Silberberg, Vice Mayor Wilson, Councilman Chapman, Councilwoman Pepper, and Councilman Smedberg; Opposed, Councilman Bailey; Absent, Councilman Lovain.

2. Mayor Silberberg reported that she and other City staff members visited the archaeological excavation along the Waterfront. Mayor Silberberg stated that several ships had been found at the Robinson Terminal South site and the ships are from the mid-1700s. Mayor Silberberg noted there would be a chance for the public and media to visit the site. City Manager Jinks noted there are over 100,000 artifacts have been located and there will be a chance for the public to see the excavation soon.

3. Councilman Chapman recognized that April 10th was Equal Pay Day for working toward achieving pay equity. Councilman Chapman asked for information on asking questions regarding pay history as it relates to City employment and he requested a discussion be scheduled to address the issue.

4. Vice Mayor Wilson reported that he and Councilman Smedberg issued a memorandum about consolidation of the Boards of Architectural Review and he explained the reasoning for the memorandum, noting the use of administrative appeals in the Parker-Gray District, the length and number of meetings held by the Board of Architectural Review (BAR)-Parker-Gray, and the historical precedent of the Boards being one during its initial conception. Vice Mayor Wilson requested that the City Manager docket for the next meeting the potential initiation of a text amendment and give Council the chance to discuss the possible consolidation fully and if Council wants to initiate the process. Councilman Smedberg noted that the idea for the consolidation had been vetted with the City Attorney's Office and with the Planning Staff to ask questions that would be of concern with the community. Council had a discussion about whether to have the discussion should be docketed for consideration and whether such an action was needed.

**WHEREUPON**, upon by Vice Mayor Wilson, seconded by Councilman Smedberg and carried 5-1, City Council passed a motion to docket at the next legislative meeting a question of whether to have staff study the issue of BAR consolidation and bring back a recommendation to the Planning Commission and the City Council. The vote was as follows: In favor, Vice Mayor Wilson, Councilman Bailey, Councilman Chapman, Councilwoman Pepper, and Councilman Smedberg; Opposed, Mayor Silberberg; Absent, Councilmember Lovain.
