1. Calling the Roll.

Mayor Silberberg called the meeting to order and the City Clerk called the roll. All the members of Council were present, with Councilman Bailey, Councilman Chapman, and Councilwoman Pepper arriving during the closed executive session.

2. 6:00 p.m. - Consideration of a Closed Executive Session for consultation with legal counsel to discuss or consider the disposition of publicly held real property.

WHEREUPON, upon motion by Vice Mayor Wilson, seconded by Councilman Smedberg and carried 4-0, City Council convened in closed executive session at 6:06 p.m., to discuss or consider the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position of the City; specifically, the proposed sale price and conditions for two City owned real estate parcels; pursuant to Section 2-2-3711(A)(3) of the Code of Virginia. In favor, Mayor Silberberg, Vice Mayor Wilson, Councilmember Lovain, and Councilman Smedberg; Opposed, none; Absent, Councilman Bailey, Councilman Chapman, and Councilwoman Pepper.

WHEREUPON, upon motion by Vice Mayor Wilson, seconded by Councilman

Smedberg and carried unanimously, City Council reconvened in open session at 7:28 p.m. The vote was follows: In favor, Mayor Silberberg, Vice Mayor Wilson, Councilman Bailey, Councilman Chapman, Councilmember Lovain, Councilwoman Pepper, and Councilman Smedberg; Opposed, none.

WHEREUPON, upon motion by Vice Mayor Wilson, seconded by Councilman Smedberg and carried unanimously by roll-call vote, City Council adopted the resolution regarding the closed executive session previously circulated to Council. The vote was follows: In favor, Mayor Silberberg, Vice Mayor Wilson, Councilman Bailey, Councilman Chapman, Councilmember Lovain, Councilwoman Pepper, and Councilman Smedberg; Opposed, none.

ORAL REPORTS FROM CITY COUNCIL ON BOARDS, COMMISSIONS, AND COMMITTEES

*City Council/INOVA Alexandria Hospital Task Force (Councilman Bailey and Councilman Smedberg)

Council/INOVA Alexandria Hospital Task Force meeting and he noted that the main discussion was on the opioid crisis. Councilman Bailey reported that there have been 50 non-fatal incidents and 9 fatal incidents related to the opioid epidemic in Alexandria in 2017. Councilman Bailer also reported that the Opioid Work Force Group was focusing on prevention and education, addiction treatment, overdose response and recovery, diversion into treatment and supply reduction. Councilman Bailey reported that group has been meeting monthly, they have a new website, and people are assisted immediately. Councilman Bailey noted that the police are sending detectives to investigate when an overdose occurs and there is information on their website for locations to dispose of unused and old drugs.

Councilman Smedberg reported that Medicaid expansion has been passed by the State and it will present some challenges to prepare people to get people into the process for those in need.

Councilmember Lovain requested the Annual Report from INOVA be sent so that Council can review how the money is being spent.

*Washington Metropolitan Area Transit Authority (WMATA) (Councilman Smedberg)

Councilman Smedberg reported that the Finance committee will be discussing Metrorail and bus changes at the upcoming meeting. Councilman Smedberg noted that the Business Oversight Committee have been reviewing the by-laws with the other jurisdictions to make sure they are in compliance with the requirements from the State. Councilman Smedberg noted that there is a lot work to codify the rules.

Councilman Smedberg reported that there is an 88% on-time performance for Metrorail, 76% customer satisfaction in the third quarter, 85% of the 5000 series cars are out of service and all the 1000 series and 4000 series are gone, railcar offloads are down 60% and bus

on-time performance is at 79%. Councilman Smedberg noted that 95% of the capital budget will be spent on safety and maintenance this year.

*Northern Virginia Transportation Commission (NVTC) (Councilman Smedberg)

Councilman Smedberg stated NVTC passed two important documents for VRE, including a year-long extension with CSX and Norfolk Southern.

Councilmember Lovain reported that Rob Fuentes presented on transit trends nationwide, noting that there is a decline in transit, with the exception of cities that are retooling their transit routes, particularly buses.

Councilman Smedberg noted that the NVTC will hold a strategic retreat on June 22 to discuss the management of major projects, like Metro funding transfers, the I-66 funding, I-395 funding, and grant administration. Councilman Smedberg stated that will review the general structure of the organization to ensure it is running efficiently.

ORAL REPORT FROM THE CITY MANAGER

City Manager Jinks gave an update on the CSX Train derailment on Eisenhower Avenue. Mr. Jinks reported that the National Transportation Safety Board (NTSB) released a preliminary report confirming that there was railbed ballast erosion further west on the tracks causing the accident to occur. Mr. Jinks reported that there will be additional heavy fire and medical services personnel at Station 206 on Seminary Road. Mr. Jinks noted that the station will now be staffed 24/7 and it will help improve response times. Mr. Jinks reported that there as a Potomac River Ferry Summit held on June 4 sponsored by the regional commission and Alexandria would not be a planned stop on the proposed system that would start in Woodbridge and end at Boling Air Force Base. Mr. Jinks reported that the King Street Initiative funded in the FY19 budget has begun, including additional staff for cleaning, public-private funding for marketing of business and activities along King Street, investment for the dock for the tall ship that will make its permanent home in Alexandria in 2019, and money for flower baskets along the corridor for beautification. Mr. Jinks reported that the City has agreed to use Airbnb tax collection system and in the month of April the City received \$36,000 in taxes from the collection. Mr. Jinks gave some statistics on how many properties taxes were collected from and the average rooms rented per day.

That the repeal provided for in section 2 of this ordinance shall not affect any offense or act committed or done, or any penalty or forfeiture incurred, or any contract established or accruing prior to the effective date of this ordinance; nor shall it affect any prosecution, suit or proceeding pending or any judgment rendered prior to said date; nor

shall it affect any ordinance adopted after January 20, 2018, which amends the Zoning Ordinance of the City of Alexandria, Virginia, 1992, as amended; nor shall it affect any ordinance saved from repeal by Ordinance No. 1250; nor shall it affect any ordinance listed in appendices A through J, both inclusive, of The Code of the City of Alexandria, Virginia, 1981, or any pages supplemental to such appendices; nor shall it affect any provision of any ordinance adopted between November 18, 2017 through January 20, 2018, inclusive, and which is inadvertently omitted from or erroneously incorporated into "The One Hundred and Twenty-Fifth Supplement to The Code of the City of Alexandria, Virginia, 1981," or any other supplement to the code; nor shall it affect any ordinance adopted after the effective date of this ordinance.

Section 4. That one complete set of pages comprising "The One Hundred and Twenty-Fifth Supplement to The Code of the City of Alexandria, Virginia, 1981," shall be stapled or otherwise permanently fastened together, shall be manually signed on the front sheet by the mayor and the city clerk, and shall be filed in the office of the city clerk and made available to any person desiring to inspect the same. In addition, one complete set of the supplemental and replacement pages of such supplement shall be properly inserted into the copy of The Code of the City of Alexandria, Virginia, 1981, which bears the manual signatures of the mayor and the city clerk, and such code, as amended and supplemented, shall be kept on file in the office of the city clerk and be made available to any person desiring to inspect the same.
