4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by		
5	adopting and incorporating therein the amendment heretofore approved by city council to		
6	the Braddock Metro Neighborhood chapter of such master plan as Master Plan Amendment		
7	No. 2018-0042 and no other amendments, and to repeal all provisions of the said master		
8	plan as may be inconsistent with such amendment.

10	WHEREAS, the City Council of the City of Alexandria finds and determines that:		
11			
12	1. In Master Plan Amendment No. 2018-0042, the Planning Commission, having		
13	found that the public necessity, convenience, general welfare and good zoning practice so		
14	require, recommended approval to the City Council on September 6, 2018 of an amendment to		
15	the Braddock Metro Neighborhood Chapter of the Master Plan of the City of Alexandria to		
16	amend the Development Table & the Land Use table of the Braddock Metro Neighborhood Plan		
17	to list the individual sites located within the Route 1 Triangle Site (Site 8) and revise the zoning		
18	and maximum allowable floor area for this site, which recommendation was approved by the		
19	City Council at public hearing on September 15, 2018;

21	2. The said amendment has heretofore been approved by the Planning Commission		
22	and City Council after full opportunity for comment and public hearing.

24	3. All requirements of law precedent to the adoption of this ordinance have been		
25	complied with; now, therefore,

27	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

29	Section 1. That the Braddock Metro Neighborhood Chapter of the Master Plan of		
30	the City of Alexandria, be, and the same hereby is, amended by amending the Development		
31	Table & the Land Use table of the Braddock Metro Neighborhood Plan to list the individual sites		
32	located within the Route 1 Triangle Site (Site 8) and revising the zoning and maximum allowable		
33	floor area for this site, as shown on the table attached hereto and incorporated fully herein by		
34	reference.

36	Section 2. That the director of planning and zoning be, and hereby is, directed to		
37	record the foregoing master plan amendment as part of the Master Plan of the City of		
38	Alexandria, Virginia.

40	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,		
41	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.		
42	Section 4. That the Master Dier of the City of Alexandric as such all (1)
