1) Blue Bird's SUP does not govern the pickup of children from the playground, and therefore it is no violation to pick them up there. The SUP specifically says that when children are picked up "from the center," it should be done using legal parking spaces or the designated loading zone. (Condition 8). There are no restrictions given regarding the pickup of children from the playground.

The only place children may not be picked up from is Duke Street. (Condition 7).

If the Blue Bird children were on a field trip to City Hall, and a parent picked its child up there, is that a violation of the SUP? If the Blue Bird children were on a walk down King Street to the Potomac River, and a parent picked its child up there, would that be a violation of the SUP? According to the Notice of Violation, it would. Blue Bird does not agree. The SUP simply does not govern where children may *not* be picked up from, with the single exception of Duke Street.

SUPs are legislative acts by City Council, and legislation must be interpreted by giving its words their plain meaning. An SUP means what it says, and doesn't mean what it doesn't say.

2) No business can be found to have violated its SUP due to the behavior of its customers.

If a parent arrives to pick up his or her child while the child is at the playground, Blue Bird cannot refuse, and kidnap the child. Blue Bird cannot tell an adult that they cannot have their child back unless they drive to the end of Commerce Street and wait there.

Whatever Blue Bird wishes its parents would do, it is not responsible for the independent acts of adults not under its control. And those acts do not represent a violation by Blue Bird of its SUP.

Many of the kids are too young to go to the playground, much of the year is too cold to ever go to the playground, and even in the temperate season they don't go in inclement weather. Of kids that go to the playground, a small number of their parents happen to come for pickup while they're there. (I think I said some of this in the filing; I'm just repeating it for context of the number of actual pickups, not to drum it in.)

The maximum possible number of children permitted for safety reasons to be on the playground at a time is 60. That capacity does not occur frequently; what actually happens is that the classes rotate through so it's not too crowded.

Yes, to the best of our knowledge, of parents who arrive to pick their kids up in a car at the actual day care center, they use the cul-de-sac.

Many of the kids are too young to go to the playground, much of the year is too cold to ever go to the playground, and even in the temperate season they don't go in inclement weather. 

Blue Bird of 346 Commerce Street is using a playground on the 200 block of Commerce St in the afternoons. Parents are picking their children up from that location which has no parking and is located on a narrow two way street. The parents park on the north side facing oncoming traffic (parked in a no parking zone facing oncoming traffic). Two phone calls to the schools has not resulted in this stopping. The parents have not been told that this is a two way street that they are driving down during rush hour on the wrong side. Nor have they been told that they can't do school pick up from this location, as I'm certain this isn't in the school's SUP. I've called parking enforcement several times as well to request that they park and ticket people between 4:30 and 5 when this occurs.

Details: Blue Bird of 346 Commerce Street is using a playground on the 200 block of Commerce St in the afternoons. Parents are picking their children up from that location which has no parking and is located on a narrow two way street. The parents park on the north side facing oncoming traffic (parked in a no parking zone facing oncoming traffic). Two phone calls to the schools has not resulted in this stopping. SITE PLAN ATTACHMENT TO BLUE BIRD PICKUP PLAN APPLICATION

The notations indicate the number of public parking spaces located in each area, which the parents can use when available. The "cc" indicates the curb cut for the lce House parcel at the corner of Commerce Street and N. Payne Street. That building is currently vacant, so parents temporarily stopping in front of the unused curb cut to buckle their children into seatbelts should not be an imposition.

Blue Bird will verbally instruct its parents to pick up their children on the south side of the street, in the travel direction indicated by the arrows, above. It will also distribute a quarterly communication to all parents to the same effect.

Blue Bird will also post a laminated sign on the outside fence of the playground with the Blue Bird logo and the words "NO STOPPING OR PICKUP THIS SIDE."

As noted in the Pickup Plan Application, Blue Bird supports the vigorous enforcement of City parking and traffic regulations against any parent who violates them.

As set forth in the SUP, Blue Bird uses the playground in the 200 block of Commerce Street for the children to get fresh air and exercise at recess. We understand that there has been a neighbor complaint about parents arriving to pick up their children while the children are at the playground.

Fundamentally, Blue Bird does not believe this parent pickup constitutes a problem worthy of attention. This happens, at most, 1) for the minority of children who go to the playground, 2) on days nice enough for the children to be at the playground, 3) when the parent happens to come at the time their child is actually at the playground.

However, in light of the fact that the City has threatened violation notices, Blue Bird is willing to offer formal revisions to its pick-up procedures as follows:

Blue Bird is not able to control when parents arrive to pick up their children. Regional traffic, and each parent's work and life schedules are different. If a parent arrives at a time that their child is at the playground, Blue Bird cannot withhold the child from their parent, subject to a march back to the daycare center a block and a half away.

Relatedly, Blue Bird cannot control from what direction individual parents traverse the public two-way Commerce Street to arrive at the playground. Blue Bird would support a public initiative to make the 200 block of Commerce Street one-way, were that the City's desire.

Blue Bird would also support making the two parking spaces across from the playground into a non-exclusive Loading Zone, which could be used both by parents picking up their children as well as the Ice House at the corner of Commerce and Payne Streets, when it becomes occupied. For now, that facility has a double-wide curb-cut that goes unused where parents could stop temporarily while picking up their children.

Blue Bird will distribute a communication to all parents, quarterly, reminding them to pick up their children on the south side of the street. (This will of course result in parents and children crossing the street from the playground to the south side.) Blue Bird will also post a laminated sign on the outside fence of the playground with the Blue Bird logo and the words "NO STOPPING OR PICKUP THIS SIDE."

If stopping for any reason on the westbound (north) side of Commerce Street is prohibited and problematic, then Blue Bird requests that the City's parking enforcement patrol and enforce the prohibition, in conjunction with Blue Bird's efforts described above.

The majority of Blue Bird children would continue to be picked up at the daycare center itself.

It seems unlikely that the Director of T&ES can take no action on "[any] matter concerning traffic or parking" unless it has been previously heard by the TPB.

Conversely, if the TPB dockets are only populated by those things the Director has predetermined he will take action on, the TPB exists purely as a rubber stamp? Do the citizen members know that?

I have a client who is convinced that the City is discriminating against him, and is inclined to be litigious and pugilistic.

I have been around too long to agree with him. I know that sometimes you win, and sometimes you lose, but Staff applies the rules evenly and everybody gets a fair shake. So, I have been doing my level best to encourage him to make good-faith use of the processes the City has in place. I have appreciated Ann and Madeleine's help with those processes so far.

I'm at a loss to explain to him why he is not entitled to a public hearing before a board composed of his fellow citizens that literally exists to consider this very issue, and does so frequently.

On the September 2017 TPB docket, four existing on-street parking spaces were converted to *two* loading zones to facilitate drop-off and pickup from a daycare facility, in response to a direct request from that facility. My client's matter is so different? He doesn't even get a hearing?

Thank you for agreeing to pursue approval of a loading zone from the Traffic and Parking Board this month. Recently, colleagues in the Transportation & Environmental Services, who are involved with this Board, have informed us that they would not support a loading zone on the 200 block of Commerce Street as a "no parking" limitation on the north side of the block must be maintained due to the narrow width of the street. In addition, the south side of the block includes a number of curb cuts and few parking spaces to support a loading zone.

As you are aware, an approved pick up and drop off plan exists and can be found on pages 29-30 of the attached SUP and related materials. This requires that parents pick up and drop off children in the four-space loading zone, located in the cu-de-sac in front of the 346 Commerce Street entrance of the day care establishment. In addition, condition #8 of SUP 2007-0064 (page 5) requires that "[L]legal parking spaces or the designated loading zone must be used when dropping off or picking up children from the center." The pick-up and drop off plan does not include an option for parents to park on the 200 block of Commerce Street or any other street other than the loading zone area in front of 346 Commerce Street.

In the absence of a revised pick up and drop off plan, approved by staff, the applicant must adhere to Condition #8 and to the existing pick up and drop off plan unless and until a revised plan has been submitted and approved by staff. Violations of the condition and/or the pick up and drop off plan will result in enforcement action. Please advise your client to inform the parents of the Bluebird day care establishment's pick up and drop off plan. For parents who are picking children up at the playground, they can park in the existing loading zone spaces at 346 Commerce Street for up to 10 minutes, activate the hazard lights, and walk to the playground and back to their cars with their children.

We appreciate your client's immediate cooperation with all terms and conditions of the SUP and the pick up and drop off plan.

We need to know an estimate of how many children get picked up from the playground, what would be the maximum? I understand this fluctuating depending on the day (and weather patterns), however we need to ensure the loading area is sufficient for pick-up. Recently, colleagues in the Transportation & Environmental Services, who are involved with this Board, have informed us that they would not support a loading zone on the 200 block of Commerce Street as a "no parking" limitation on the north side of the block must be maintained due to the narrow width of the street. In addition, the south side of the block includes a number of curb cuts and few parking spaces to support a loading zone.

As you are aware, an approved pick up and drop off plan exists and can be found on pages 29-30 of the attached SUP and related materials. This requires that parents pick up and drop off children in the four-space loading zone, located in the cu-de-sac in front of the 346 Commerce Street entrance of the day care establishment. In addition, condition #8 of SUP 2007-0064 (page 5) requires that "[L]legal parking spaces or the designated loading zone must be used when dropping off or picking up children from the center." I'm at a loss to explain to him why he is not entitled to a public hearing before a board composed of his fellow citizens that literally exists to consider this very issue, and does so frequently.

On the September 2017 TPB docket, four existing on-street parking spaces were converted to *two* loading zones to facilitate drop-off and pickup from a daycare facility, in response to a direct request from that facility. My client's matter is so different? He doesn't even get a hearing?

In addition, the south side of the block includes a number of curb cuts and few parking spaces to support a loading zone.

As you are aware, an approved pick up and drop off plan exists and can be found on pages 29-30 of the attached SUP and related materials. This requires that parents pick up and drop off children in the four-space loading zone, located in the cu-de-sac in front of the 346 Commerce Street entrance of the day care establishment. In addition, condition #8 of SUP 2007-0064 (page 5) requires that "[L]legal parking spaces or the designated loading zone must be used when dropping off or picking up children from the center." Of kids that go to the playground, a small number of their parents happen to come for pickup while they're there. Thank you for agreeing to pursue approval of a loading zone from the Traffic and Parking Board this month. Recently, colleagues in the Transportation & Environmental Services, who are involved with this Board, have informed us that they would not support a loading zone on the 200 block of Commerce Street as a "no parking" limitation on the north side of the block must be maintained due to the narrow width of the street. In addition, the south side of the block includes a number of curb cuts and few parking spaces to support a loading zone.

As you are aware, an approved pick up and drop off plan exists and can be found on pages 29-30 of the attached SUP and related materials. This requires that parents pick up and drop off children in the four-space loading zone, located in the cu-de-sac in front of the 346 Commerce Street entrance of the day care establishment. In addition, condition #8 of SUP 2007-0064 (page 5) requires that "[L]legal parking spaces or the designated loading zone must be used when

dropping off or picking up children from the center." The pick-up and drop off plan does not include an option for parents to park on the 200 block of Commerce Street or any other street other than the loading zone area in front of 346 Commerce Street.

In the absence of a revised pick up and drop off plan, approved by staff, the applicant must adhere to Condition #8 and to the existing pick up and drop off plan unless and until a revised plan has been submitted and approved by staff. Violations of the condition and/or the pick up and drop off plan will result in enforcement action. Please advise your client to inform the parents of the Bluebird day care establishment's pick up and drop off plan. For parents who are picking children up at the playground, they can park in the existing loading zone spaces at 346 Commerce Street for up to 10 minutes, activate the hazard lights, and walk to the playground and back to their cars with their children.

We appreciate your client's immediate cooperation with all terms and conditions of the SUP and the pick up and drop off plan.

Thanks for the email.

Many of the kids are too young to go to the playground, much of the year is too cold to ever go to the playground, and even in the temperate season they don't go in inclement weather. Of kids that go to the playground, a small number of their parents happen to come for pickup while they're there. (I think I said some of this in the filing; I'm just repeating it for context of the number of actual pickups, not to drum it in.)

The maximum possible number of children permitted for safety reasons to be on the playground at a time is 60. That capacity does not occur frequently; what actually happens is that the classes rotate through so it's not too crowded.

Yes, to the best of our knowledge, of parents who arrive to pick their kids up in a car at the actual day care center, they use the cul-de-sac.

Oh, interesting about the 200 Commerce Street. Thanks for that info. I haven't seen any activity over there, but take your point about the use of the curbcut into the future. That same company just opened a place at Pentagon Row, and also comes out to a farmer's market in Washington, VA that I go to lots of weekends.


<u>PLANNING COMMISSION ACTION, OCTOBER 2, 2007</u>: On a motion by Mr. Komoroske and seconded by Mr. Robinson, the Planning Commission voted to <u>recommend</u> <u>approval</u> subject to compliance with all applicable codes, ordinances, and staff recommendations. The Planning Commission directed staff to evaluate the applicant's request for greater enrollment before the October 13 City Council hearing. The motion carried on a vote of 6-0-1. Mr. Dunn recused himself.

<u>Reason:</u> The Planning Commission agreed with the staff analysis.

Speakers:

Ms. Ulka Patel, of Nealon & Associates, representing the applicant, requested an amendment to condition number 2 to allow for a total of 147 children to be cared for at the center. The request was prompted by a re-evaluation of the property by Virginia Department of Social Services.

<u>STAFF RECOMMENDATION</u>: Staff recommends **approval** subject to compliance with all applicable codes and ordinances and the recommended permit conditions found in Section III of this report.



I. DISCUSSION

<u>REQUEST</u>

The applicant, J, S and Family, requests special use permit approval for the operation of a day care and private school located at 1447 Duke Street.

SITE DESCRIPTION

The subject property is one lot of record with 52 feet of frontage on Duke Street, 54 feet of depth and a total lot area of 2,943 square feet. The site is developed with a three story office building. Access to the property is from Duke Street and Commerce Street.

The surrounding area is occupied by a mix of residential and office uses. Immediately to the north are residential townhouses. To the south are townhouses developed with offices and residences. To the east are residential townhouses and to the west are offices.



BACKGROUND

On September 18, 1999, City Council granted Special Use Permit #99-0068 to St. Coletta's Private School for the operation of a private school with 45 students, located at 1447 Duke Street. The off street parking was provided at Shiloh Baptist Church.

On November 20, 2006, staff administratively approved Special Use Permit #2006-0099, a change of ownership to Shiloh Baptist Church.

The subject property is not currently occupied.

PROPOSAL

The applicant proposes to operate a day care and private school for 111 students in the building located at 1447 Duke Street. The applicant anticipates 37 staff members to care for children and provide administrative support. The center will care for children aged six weeks to 12 years old. The applicant proposes to construct a private playground at 211 Commerce Street as an accessory use to the day care.

Hours: 7:00 am – 6:00 pm, Monday – Friday

Number of children: 111

Noise:No anticipated noise impacts at 1447 Duke Street, the playground
will have moderate noise levels from children playing outsideTrash/Litter:Trash will be collected three times per week, staff will ensure that
the children do not contribute to litter

PARKING

According to Section 8-200(A)(11) of the Zoning Ordinance, a day care center requires two parking space for every classroom. A daycare center with nine classrooms will be required to provide 18 off-street parking spaces. The applicant is leasing the required spaces from Shiloh Baptist Church at 1401 Duke Street. Shiloh Baptist has included the stipulation that the parking will not be available on days when funerals are to be held at the church. The applicant has formulated a contingency plan for staff parking on these days. On days when Shiloh Baptist has a funeral scheduled, the day care staff will be able to park at the applicant's school in Mount Vernon which has an abundance of parking. The applicant will use the center's bus to shuttle employees to work from Fairfax County. Additionally the applicant will subsidize transit fare on days when the parking lot is not available.

ZONING/MASTER PLAN DESIGNATION

The subject property is located in the CD/Commercial Downtown zone. Section 4-503(G) of the Zoning Ordinance allows a day care center in the CD zone only with a special use permit.

The proposed use is consistent with the King Street/Eisenhower Avenue Small Area Plan chapter of the Master Plan which designates the property for a mix of retail, office, and service uses.

II. STAFF ANALYSIS

Staff supports the application for child care at 1447 Duke Street. There is a great demand for quality child care in the city. With its proximity to both Old Town and the Carlyle development this location will provide convenient child care to many Alexandria residents and workers.

Staff recognizes the potential for traffic impacts on Duke Street with this use. Transportation & Environmental Services supports a loading zone at the terminus of Commerce Street for drop-off and pick-up of children. Staff has included a condition forbidding the use of Duke Street for purposes of drop-off and pick-up and a condition requiring the applicant to submit a comprehensive plan for managing the drop-off and pick-up of children to Planning & Zoning.

The applicant has acquired the property at 211 Commerce Street to use as a playground for the children. This playground will be utilized by this daycare center and the Tiny Tots Playroom that the applicant operates at 1500 King Street. Although the proposed playground is approximately 800 feet from the subject property staff believes that this will be an acceptable site for a playground as the route is relatively free of traffic.

With the following conditions, staff recommends approval of the special use permit.

III. RECOMMENDED CONDITIONS

Staff recommends **approval** subject to compliance with all applicable codes and ordinances and the following conditions:

- 1. The special use permit shall be granted to the applicant only or to any corporation in which the applicant has a controlling interest. (P&Z)
- 2. No more than 145 children shall be permitted at the day care facility. (P&Z)
- 3. The applicant shall display the number of children being served per day. (City Council)
- 4. The hours of operation of the daycare center shall be limited to Monday through Friday, 7:00 am 6:00 pm. (P&Z)
- 5. The applicant shall post the hours of operation at the entrance of the business. (P&Z)
- 6. The applicant shall encourage its employees to use mass transit or to carpool when traveling to and from work, by posting information regarding DASH and METRO routes, the location where fare passes for transit are sold, and advertising of carpooling opportunities. (P&Z)
- 7. The applicant shall conduct employee training sessions on an ongoing basis, including as part of any employee orientation, to discuss all SUP provisions and requirements. (P&Z)
- 8. Duke Street may not be used for the purpose of dropping off or picking up children from the center. (P&Z)
- 9. Legal parking spaces or the designated loading zone must be used when dropping off or picking up children from the center. (P&Z)
- 10. The applicant must submit a comprehensive plan for the management of drop-offs and pick-ups to the satisfaction of the Director of Planning & Zoning prior to issuance of an occupancy permit. (P&Z)

- 11. The outdoor play area located at 211 Commerce Street may not be used before 9:00 am. (P&Z)
- 12. The applicant shall provide storage space for solid waste and recyclable materials containers as outlined in the City's "Solid Waste and Recyclable Materials Storage Space Guidelines", or to the satisfaction of the Director of Transportation & Environmental Services. The City's storage space guidelines and required Recycling Implementation Plan forms are available at: www.alexandriava.gov or contact the City's Solid Waste Division at 703-519-3486 ext.132. (T&ES)
- 13. Litter on the site and on public rights-of-way and spaces adjacent to or within 75 feet of the premises shall be picked up at least twice a day and at the close of business, and more often if necessary, to prevent an unsightly or unsanitary accumulation, on each day that the business is open to the public. (T&ES)
- 14. The applicant shall require its employees who drive to use off-street parking and/or provide employees who use mass transit with subsidized bus and rail fare media. The applicant shall also post DASH and Metrobus schedules on-site for employees. (T&ES)
- 15. The applicant is to contact the Community Relations Unit of the Alexandria Police Department at 703-838-4520 regarding a security survey for the child care center. This is to be completed prior to the child care facility opening for business. (Police)
- 16. The applicant is to contact the Community Relations Unit of the Alexandria Police Department at 703-838-4520 regarding robbery readiness training for employees. (Police)
- 17. The Director of Planning and Zoning shall review the special use permit after it has been operational for six months and again after one year, and shall docket the matter for consideration by the Planning Commission and City Council if (a) there have been documented violations of the permit conditions which were not corrected immediately, constitute repeat violations or which create a direct and immediate adverse zoning impact on the surrounding community; (b) the director has received a request from any person to docket the permit for review as the result of a complaint that rises to the level of a violation of the permit conditions, (c) the director has determined that there are problems with the operation of the use and that new or revised conditions are needed. (P&Z)

- F-2 The applicant shall submit a detailed floorplan, outlining dimensions of the proposed space to be used and any and all fire protection systems currently in place.
- C-1 Alterations to the existing structure must comply with the current edition of the Uniform Statewide Building Code (USBC).
- C-2 Alterations to the existing structure and/or installation and/or altering of equipment therein requires a building permit. Five sets of plans, bearing the signature and seal of a design professional registered in the Commonwealth of Virginia, must accompany the written application. The plans must include all dimensions, construction alterations details, kitchen equipment, electrical, plumbing, and mechanical layouts and schematics.
- C-3 Prior to the application for new Certificate of Occupancy, the applicant shall submit a building permit for a change of use. Drawings prepared by a licensed architect or professional engineer shall accompany the permit application. These plans shall show provide existing conditions, construction type data, and a plot plan. In addition, these plans shall show proposed conditions and provide data by the design professional which details how the proposed use will comply with the current edition of the Virginia Uniform Statewide Building Code for the new use in the area of structural strength, means of egress, passive and active fire protection, heating and ventilating systems, handicapped accessibility and plumbing facilities.

Health Department:

- C-1 An Alexandria Health Department Permit is required for all regulated facilities. Permits are not transferable.
- C-2 Certified Food Managers must be on duty during all hours of operation.
- C-3 Permits must be obtained prior to operation.
- C-4 Five sets of plans must be submitted to and approved by this department prior to construction.
- C-5 This facility must meet State and City Social Service requirements for air and floor space, toilet facilities, separate isolation room for sick children, lighting, temperature storage for cots, clothing. Other items may be required by state or city codes.
- C-6 If food preparation or food handling is done on the premises, five sets of plans of the food handling areas are to be submitted to the Health department for approval.

- C-7 This facility must meet commercial standards (13 or more). Plans must comply with the Alexandria City Code, Title 11, Chapter 2, Food and Food Establishments. A \$135.00 fee is required for plans review of food facilities.
- C-8 If enrollment is kept to a maximum of 12 children at nay one time, the facility may use home-style (semi-public restaurant) standards for food service.

BAR:

F-1 The subject property is located in the Old and Historic Alexandria District and is under the jurisdiction of the Old and Historic Alexandria Board of Architectural Review (BAR). The request for a SUP for child day care uses at 1447 Duke Street does not appear to indicate any proposed exterior changes to the building at this time that would require a review by the BAR and the issuance of a Certificate of Appropriateness. The applicant is reminded that any future exterior changes, including new or replacement signage, lighting, window replacement, fencing, kitchen exhaust and/or new HVAC vents or fixtures, or other alterations visible from a public right-of-way would need to be submitted for review and approval by the BAR staff and the Board of Architectural Review. It is the applicant's responsibility to inform BAR Staff when new signage, lighting, or other external alterations are proposed which require BAR review and approval.

Parks and Recreation:

F-1 No comment.

Human Services:

S-1 On Friday, July 27, 2007, representatives form the office for Early Childhood Development accompanied representatives of Planning and Zoning and Code Enforcement to 1447 Duke Street, which is the proposed site for Tiny Tots II.

Staff from the Office for Early Childhood Development recommended that the applicant:

- Review with state licensing and code enforcement the more restrictive requirements for a child development center for children below the age of 2.5 years;
- Work with an engineer and/or architect to created a detailed floor plan for the proposed use;
- Determine the additional cost (if any) of adapting this site to serve infants and the number of infants that site will accommodate;

- Based on the above information, determine the feasibility of operating a child care center in this location; and
- Work with Planning and Zoning to explore options for staff parking and pick-up and drop-off procedures in the circle drive in front of the building.

Police Department:

- R-1 The applicant is to contact the Community Relations Unit of the Alexandria Police Department at 703-838-4520 regarding a security survey for the child care center. This is to be completed prior to the child care facility opening for business.
- R-2 The applicant is to contact the Community Relations Unit of the Alexandria Police Department at 703-838-4520 regarding robbery readiness training for employees.
