4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by		
5	adopting and incorporating therein the amendment heretofore approved by city council to		
6	the Potomac Yard/Potomac Greens Small Area Plan chapter of such master plan as Master		
7	Plan Amendment No. 2018-0008 and no other amendments, and to repeal all provisions of		
8	the said master plan as may be inconsistent with such amendment.

10	WHEREAS, the City Council of the City of Alexandria finds and determines that:		
11			
12	1. In Master Plan Amendment No. 2018-0008, the Planning Commission, having		
13	found that the public necessity, convenience, general welfare and good zoning practice so		
14	require, recommended approval to the City Council on November 8, 2018 of an amendment to		
15	the Potomac Yard/Potomac Greens Small Area Plan Chapter of the Master Plan of the City of		
16	Alexandria to amend the uses in CDD#10 to include home for the elderly, which		
17	recommendation was approved by the City Council at public hearing on November 17, 2018;		
18			
19	2. The said amendment has heretofore been approved by the planning commission		
20	and city council after full opportunity for comment and public hearing.		
21			
22	3. All requirements of law precedent to the adoption of this ordinance have been		
23	complied with; now, therefore,		
24	THE OTV COUNCIL OF ALEVANDUA HEDEDV ODDADIG.		
25 26	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:		
26 27	Section 1. That the Potomac Yard/Potomac Greens Small Area Plan Chapter of the		
28	Master Plan of the City of Alexandria, be, and the same hereby is, amended by changing item		
29	#1d of the "CDD Guidelines for Potomac Yard / Potomac Greens" on Page 71 to read 1,747,346		
30	net square feet of office space and adding item #1e of the "CDD Guidelines for Potomac Yard /		
31	Potomac Greens" on Page 71 to state the maximum amount of Home for the Elderly at 325,000		
32	net square feet, which may include up to 150 dwelling units, attached hereto and incorporated		
33	fully herein by reference.		
34			
35	Section 2. That the director of planning and zoning be, and hereby is, directed to		
36	record the foregoing master plan amendment as part of the Master Plan of the City of		
37	Alexandria, Virginia.		
38			
39	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,		
40	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.

42	Section 4. That the Master Plan of the City of Alexandria, as amended by this		
43	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,		
44	Virginia.
