Dear Member of City Council,

This letter is in reference to item #19, SUP 2018-0060 on this Saturday's City Council meeting, Eat Augie's LLC a restaurant located at 1106 and 1108 King Street.

While we welcome them as a neighbor in our neighborhood, we feel strongly that some neighborly compromise needs to be found on their requests in the SUP.

Specifically, we want to address the outdoor dining requests. To permit a restaurant (bar?) to extend their hours to 2:00 am with the availability to have outdoor games, televisions, and amplified (loudspeaker) live music will cause considerable disruption to our ability to enjoy our outside space and to sleep at night during the spring, summer and fall seasons. As residents of the 1100 block of Prince Street my garden is across a parking lot (open space) from the rear of Augies. There is no barrier to the noise this permission would create.

Staff also noted these concerns in their recommendations to the Planning Commission. Taken directly from their recommendation

Nonetheless, staff acknowledges the noise impacts related to late night hours for outdoor dining, outdoor amplified live entertainment, televisions or loudspeakers due primarily to the proximity of residences and, therefore, does not support these aspects of the applicant's proposal.

I request that City Council deny Augies items number 3, 11, 17 and 50 and accept the staff recommendations.
