3	AN ORDINANCE to amend and reordain Section 5-602 (Coordinated development districts
4	created, consistency with master plan, required approvals) of Article V (MIXED USED
5	ZONES) of the City of Alexandria Zoning Ordinance, in accordance with the text
6	amendment heretofore approved by city council as Text Amendment No. 2018-0016.
7	
8	WHEREAS, the City Council finds and determines that:
9	
10	1. In Text Amendment No. 2018-0016, the Planning Commission, having found that
11	the public necessity, convenience, general welfare and good zoning practice so require,
12	recommended approval to the City Council on December 4, 2018 of a text amendment to the
13	Zoning Ordinance to create CDD No. 27, Greenhill/West Alexandria Properties, which
14	recommendation was approved by the City Council at public hearing on December 15, 2018;
15	
16	2. The City Council in adopting this ordinance expressly adopts, ratifies, affirms and
17	concurs in the finding and action of the Planning Commission above stated;
18	
19	3. All requirements of law precedent to the adoption of this ordinance have been
20	complied with; now, therefore,
21	
22	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
23	
24	Section 1. That Section 5-602(A) of the Zoning Ordinance be, and the same hereby
25	is, amended by inserting new language, as shown:

1	Section 2. That the director of planning and zoning be, and hereby is, directed to
2	record the foregoing text amendment.

4	Section 3. That Section 5-602(A), as amended pursuant to Section 1 of this
5	ordinance, be, and the same hereby is, reordained as part of the City of Alexandria Zoning
6	Ordinance.
7	
8	Section 4. That this ordinance shall become effective on the date and at the time of
9	its final passage, and shall apply to all applications for land use, land development or subdivision
10	approval provided for under the City of Alexandria Zoning Ordinance which may be filed after
11	such date, and shall apply to all other facts and circumstances subject to the provisions of the
12	City of Alexandria Zoning Ordinance, except as may be provided in Article XII of the Zoning
13	Ordinance.
