### DISCUSSION

The Board unanimously stated that the applicant made a good faith effort to use the appropriate window replacement material and understood the applicant's confusion with window terminology. However, the Board member were very clear that this after-the-fact approval does not set a precedent for other properties in the district. Ms. Roberts stated that the property is setback from the street with low foot traffic and that staff should be on alert when dealing with some window representatives in the future.
