17	1201 North Royal Street from, CD-X/Commercial downtown zone (Old Town North) to CRMU-
18	X/Commercial residential mixed use (Old Town North) zone, and the adjacent outparcel from,
19	UT/Utilities and transportation to CRMU-X/Commercial residential mixed use (Old Town
20	North) zone, which recommendation was approved by the City Council at public hearing on
21	January 12, 2019;
