ORAL REPORTS FROM CITY COUNCIL ON BOARDS, COMMISSIONS, AND

COMMITTEES

*Eisenhower Partnership Board of Directors (Councilwoman Jackson)

Councilwoman Jackson reported that Ms. Beach from the Planning and Zoning Department gave presentation on Eisenhower East Small Area Plan for the Board and she noted the emphasis on teleworking as part of the updates to the plan. Councilwoman Jackson noted that there is a community outreach effort underway to learn how the community would like to see this area activated and she reported that the next meeting would be held at the Parc Meridian on February 25.

*Citizen Corps Council (Councilwoman Jackson)

Councilwoman Jackson reported that the Council met at the new Emergency Operations Center and toured the facility. Councilwoman Jackson also reported that some of the goals for 2019 are to review resources and how to improve relationships with the public and how to promote the activities of the Council, including working with the religious community to improve emergency response.

*Quality of Life Subcommittee (Mayor Wilson and Councilwoman Jackson)

Mayor Wilson reported that the subcommittee welcomed Councilwoman Jackson to the group and the meeting time has been changed. Mayor Wilson reported that there group discussed changing the formatting of the meetings and the name of the group and there will be proposal coming to Council for consideration with those recommendations.

*Alex Renew/CSO Workgroup (Mayor Wilson and Councilwoman Jackson)

Mayor Wilson reported that this was the first meeting for him and Councilwoman Jackson. Mayor Wilson reported that there will be two Development Special Use Permits coming to Council related to the work on the tunnel and the wastewater facility, in June and September respectively. Mayor Wilson noted that the group discussed the community input that has been receive thus far on the alignment of the tunnel network and Alexandria Renew has worked to incorporate that information into the project when possible. Mayor Wilson pointed that there is coordination with National Park Services on the land impacted by the project and there should be a decision from the Federal government in June. Mayor Wilson reported that there will be schedule for receiving input on the planning design, procurement and construction phases forthcoming and the members were appointed to the River Renew Stakeholders Advisory Group. Mayor Wilson also reported that rate recommendations would be coming from the Alexandria Renew staff to the Board in February, with finalization in May.

*Potomac Yard Metrorail Implementation Work Group (PYMIG)(Mayor Wilson and Councilman Aguirre)

Mayor Wilson reported that the meeting was focused on the environmental permit discussion and notification was received that the revised permit applications were submitted and there will be public comment period before the permits are finalized. Mayor Wilson also reported that there was a conversation with contractors over their findings and there were changes that were made to the area of disturbance to ensure the minimal amount of impact on the wetlands. Mayor Wilson noted that the process going forward, particularly working with

WMATA and the contractor to examine how the \$50 million provided by the State will be incorporated to support additional entrance to the station.

*City/Schools Subcommittee (Mayor Wilson and Councilman Chapman)

Mayor Wilson noted that Councilman Chapman was welcomed to the group as was the Vice Chair Nolan from the School Board to the group. Mayor Wilson reported that an update on afterschool and moving forward on the recommendations that staff provided. Mayor Wilson reported that the status of the enrollment forecast and how development pressures with affect the forecast. Mayor Wilson also pointed out that there was a discussion about the future use and planning Potomac Yard site.

*Transportation Commission (Councilman Aguirre and Councilman Chapman)

Councilman Chapman reported that there will be a joint work session with the Alexandria Transit Board to discussion the Transit Vision Plan on March 13 at 7 p.m. the DASH headquarters.

*Update on Northern Virginia Regional Commission (NVRC)(Councilwoman Pepper)

Councilwoman Pepper that the NVRC received a report on cybersecurity and how it will affect the region and what communities need to be ready for a cyberattack. Councilwoman Pepper reported that there is not an adequate workforce to handle a crisis in cybersecurity. Councilwoman Pepper noted that NVRC has been focusing on the issue of cybersecurity and has developed thirteen priorities to make the region ready.

Councilman Aguirre gave an update on the Northern Virginia Transportation Commission, reporting that he attended Transportation Lobby Day in Richmond on January 28. Councilman Aguirre reported that the large contingent from Northern Virginia participated to ensure that the transportation needs for the regional will be a met. Councilman Aguirre reported that the attended the NVTC Legislative subcommittee meeting and noted that there was a lot of work going on at the State and Federal level to promote rebuilding the transportation infrastructure.

Vice Mayor Bennett-Parker reported that the attended the first Program Advisory subcommittee meeting and she will participating in smaller workgroup that will be discussing the I395/95 projects and the funds from the tolls that may be able to relieve congestion.

ORAL REPORT FROM THE CITY MANAGER

City Manager Jinks reported that he would be presenting the FY2020 Budget and 10-year Capital Improvement Program on February 19 at 7:00 p.m., followed by a work session on revenues.

City Manager Jinks reported that Virginia Association of Museum has ranked Alexandria #1 on its list for endangered artifacts with the first carriage at the Friendship Firehouse receiving the most votes and the City was awarded a check in the amount of \$4000.

City Manager Jinks noted that item #13 is regarding a grant from the Mars Cooperation to do research on heritage chocolate and they are offering a grant to the Office of Historic

Alexandria in the amount of \$10,000 to conduct the research. City Manager Jinks thanked Gretchen Bulova, Director, Office of Historic Alexandria, for seeking the grant funding.

ORDINANCE NO. 5200

AN ORDINANCE adopting supplemental pages for The Code of the City of Alexandria, Virginia, 1981, as amended, and providing for the repeal of ordinances not included therein, except those saved from repeal by this ordinance, and for other purposes.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That the sections and portions thereof set forth in the supplemental and replacement pages for The Code of the City of Alexandria, Virginia, 1981, each of which pages is identified in the lower left-hand corner by the notation "Supp. No. 129," are hereby adopted as and shall constitute "The One Hundred and Twenty-Ninth Supplement to The Code of the City of Alexandria, Virginia, 1981."

Section 2. That the sections and portions thereof set forth in "The One Hundred and Twenty-Ninth Supplement to The Code of the City of Alexandria, Virginia, 1981" shall be in force and effect on and after the effective date of this ordinance, and all ordinances of a general and permanent nature which were adopted between October 13, 2018 through December 15, 2018, inclusive, and which are not included in such supplement or in The Code of the City of Alexandria, Virginia, 1981, as amended, are hereby repealed, except as otherwise provided in section 3 of this ordinance.

Section 3. That the repeal provided for in section 2 of this ordinance shall not affect any offense or act committed or done, or any penalty or forfeiture incurred, or any contract established or accruing prior to the effective date of this ordinance; nor shall it affect any prosecution, suit or proceeding pending or any judgment rendered prior to said date; nor shall it affect any ordinance adopted after October 13, 2018, which amends the Zoning Ordinance of the City of Alexandria, Virginia, 1992, as amended; nor shall it affect any ordinance saved from repeal by Ordinance No. 128; nor shall it affect any ordinance listed in appendices A through J, both inclusive, of The Code of the City of Alexandria, Virginia, 1981,

or any pages supplemental to such appendices; nor shall it affect any provision of any ordinance adopted between October 13, 2018 through December 15, 2018, inclusive, and which is inadvertently omitted from or erroneously incorporated into "The One Hundred and Twenty-Ninth Supplement to The Code of the City of Alexandria, Virginia, 1981," or any other supplement to the code; nor shall it affect any ordinance adopted after the effective date of this ordinance.

Section 4. That one complete set of pages comprising "The One Hundred and Twenty-Ninth Supplement to The Code of the City of Alexandria, Virginia, 1981," shall be stapled or otherwise permanently fastened together, shall be manually signed on the front sheet by the mayor and the city clerk, and shall be filed in the office of the city clerk and made available to any person desiring to inspect the same. In addition, one complete set of the supplemental and replacement pages of such supplement shall be properly inserted into the copy of The Code of the City of Alexandria, Virginia, 1981, which bears the manual signatures of the mayor and the city clerk, and such code, as amended and supplemented, shall be kept on file in the office of the city clerk and be made available to any person desiring to inspect the same.

Section 5. This ordinance shall become effective upon the date and at the time of its final passage.

ORDINANCE NO. 5201

AN ORDINANCE adopting supplemental pages for the Zoning Ordinance of the City of Alexandria, Virginia, 1992, as amended, and providing for the repeal of ordinances not included therein, except those saved from repeal by this ordinance, and for other purposes.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 2. That the sections of the Zoning Ordinance, and the portions thereof, set forth in "The Eightieth Supplement to the Zoning Ordinance of the City of Alexandria, Virginia, 1992," shall be in force and effect on and after the effective date of this ordinance, and all ordinances amending the text of the Zoning Ordinance which were adopted between October 13, 2018 and December 15, 2018, and which are not included in such supplement or in the Zoning Ordinance are hereby repealed, except as otherwise provided in section 3 of this ordinance.

Section 3. That the repeal provided for in section 2 of this ordinance shall not affect any offense or act committed or done, or any penalty or forfeiture incurred, or any contract established or accruing prior to the effective date of this ordinance; nor shall it affect any prosecution, suit or proceeding pending or any judgment rendered prior to said date; nor shall it affect any provision of any ordinance amending the Zoning Ordinance which was adopted between October 13, 2018 and December 15, 2018 inclusive, and which is inadvertently omitted from or erroneously incorporated into "The Eightieth Supplement to the Zoning Ordinance of the City of Alexandria, Virginia, 1992"; nor shall it affect any ordinance adopted after the effective date of this ordinance.

Section 4. That one complete set of pages comprising "The Eightieth Supplement to the Zoning Ordinance of the City of Alexandria, Virginia, 1992," shall be stapled or otherwise permanently fastened together, shall be manually signed on the front sheet by the mayor and the city clerk, and shall be filed in the office of the city clerk and made available to any person desiring to inspect the same. In addition, one complete set of the pages comprising such supplement shall be properly inserted into the copy of the Zoning Ordinance of the City of Alexandria, Virginia, 1992, which bears the manual signatures of the mayor and the city clerk, and such code, as amended and supplemented, shall be kept on file in the office of the city clerk and be made available to any person desiring to inspect the same.

Section 5. That this ordinance shall become effective upon the date and at the time of its final passage.

WHEREAS, pursuant to Section 36-55.30:2.A of the Code of the Virginia of 1950, as amended, the City Council of the City of Alexandria, Virginia, desires to designate the site of the proposed Fairlington Presbyterian Church Apartments, as shown on Exhibit A attached hereto, as a Revitalization Area (Area); and

WHEREAS, the industrial, commercial or other economic development of the proposed Revitalization Area will benefit the City, but such Area lacks the housing needed to induce manufacturing, industrial, commercial, governmental, educational, entertainment, community development, healthcare or nonprofit enterprises or undertaking to locate or remain in such Area; and

WHEREAS, private enterprise and investment are not reasonably expected, without assistance, to produce decent, safe and sanitary housing and supporting facilities that will meet the needs of low- and moderate-income persons and families in such Area and thereby create a desirable economic mix of residents in such Area; and

WHEREAS, Wesley Fairlington, LLC proposes to construct a new multifamily building containing approximately 81 rental units affordable to households at a range of incomes, from 40% to 60% of the Area Median Income (AMI), in the Area, thereby creating a mixed income

community with the larger neighborhood; and

WHEREAS, the affordable housing proposed would not be economically feasible without the provision of federal low-income housing tax credits and significant City investment at advantageous rates and terms; and

WHEREAS, the proposed development will provide a critical source of affordable housing for current and future low- and moderate-income residents at a range of incomes whose tenancy and local employment is essential to the Area's future economic development and sustainability, as well as to the City's strategic goal of maintaining neighborhoods that are diverse, inclusive and true mixed-income communities;

NOW, THEREFORE, BE IT HEREBY RESOLVED that pursuant to Section 36-55.30:2.A of the Code of Virginia, 1950, as amended, the Area is hereby designated as a revitalization area.

WHEREAS, there might be an undercount in the year 2020 unless a similar effort is mounted to encourage the public to participate in the Census; and

WHEREAS, the City Council wishes to establish a Complete Count Committee charged with the responsibility of ensuring that all City residents participate in the year 2020 Census.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA, VIRGINA THAT:

- 1. There is hereby established an ad hoc committee known as the Alexandria Complete Count Committee ("Committee").
- 2. City Council will appoint a Chair of the Committee and its <u>initial</u> members <u>with the balance of the Committee and the Committee's Steering Committee appointed by the City Manager in consultation with the Committee Chair.</u>
- 3. The Committee shall consist of <u>at least</u> 35 members representing a broad cross section of Alexandria's population. It is particularly important that the Committee have strong representation from civic associations, community-based organizations, the business

community, and organizations that serve the population that is most likely to be undercounted.

- 4. The function of the Committee shall be as follows:
 - (1) Establish a list of groups that will be targeted for priority attention in an effort to encourage their members to be counted in the year 2020 Census;
 - (2) Develop a program to encourage participation in the year 2020 Census by the public generally, and by the target groups in particular; and
 - (3) Prepare recommendations to staff about expenditures of funds to accomplish item number 2 above in an amount not to exceed the established budget.
- 5. The Committee is empowered to adopt rules regarding procedure and other matters so long as the same are not inconsistent with the City Code including, but not limited to, the establishment of subcommittees through which it may carry on its functions and purposes.
- 6. The Committee shall prepare a brief report upon completion of its activities and submit the report to City Council.
- 7. The Committee shall sunset upon completion of its activities in 2020.
- 35. Consideration of a Resolution to Support an Amended Grant Application to the Virginia Department of Rail and Public Transportation (DRPT) for FY 2020 State Aid Grant Programs.[ROLL-CALL VOTE]

RESOLUTION TO SUPPORT PROPOSED TRANSPORTATION PROJECT APPLICATION FOR THE VIRGINIA DEPARTMENT OF RAIL AND PUBLIC TRANSPORTATION STATE AID GRANT PROGRAM FOR FY 2020

WHEREAS, in 2018, the General Assembly passed HB 1539, which required the Commonwealth Transportation Board (CTB) to update the State Aid Grant Programs for operating and capital assistance based on performance metrics beginning in FY 2020; and

WHEREAS, HB 1539 establishes separate prioritization processes for the Board's Six Year-Improvement Program, state of good repair projects, and major expansion projects and makes numerous changes to the administration of revenues for mass transit in the Commonwealth; and

WHEREAS, the purpose of the State Aid Grant Program is to fund transportation projects through a prioritization process that evaluates each project's merits using key benefits related to congestion mitigation, economic development, accessibility, safety, environmental quality and land use; and

WHEREAS, the FY 2020 capital assistance projects will be scored and prioritized based on the new Transit Capital Prioritization Process to determine which projects attain and maintain a state of good repair for transit assets, while also supporting needs beyond state of good repair that would enhance transit utilization, efficiency, and reduce congestion; and
