It will almost certainly scare away customers from the other established businesses near there such as the dog walking/training business. I believe there is also a yoga studio, pet food store and cat shelter nearby. From what I have read about such slaughterhouses, they are smelly; difficult to monitor to ensure they are complying with laws and regulations; and noisy as the animals are not stunned before they are killed. Some have suggested these slaughterhouses violate federal laws with their treatment of the animals. The smells and noises would likely disturb the dogs at the nearby training business and the cats at the shelter if they travel that far. I will not be visiting this area of town if this business opens there, and I imagine many residents feel similarly. The City of Alexandria is not an appropriate location for a slaughterhouse operation such as this, no matter how "small."

The location, which is in the city limits of Alexandria, proposes that a slaughter house be approved to operate where, we understand, animals will be subjected to lethal cuts and allowed to bleed out to their death. This raises grave concerns on many levels including the disposal of animal remains, blood, and other pollutants, etc. Also released into the community ecosystem will be feathers from chickens, bacteria such as salmonella, fungus and mold spores, and parasites. We travel to Colvin Street more than five days a week to have our dog boarded and visit the recycling center at least once a week. In addition to the effect such a facility may have on my family and I, our dog will be subjected to potential illness from this propose slaughter house which, like other residents to visit Colvin Street, will then be returned to families' residences.

Kindly consider these comments and reject the proposal to allow this business to operate in Alexandria. 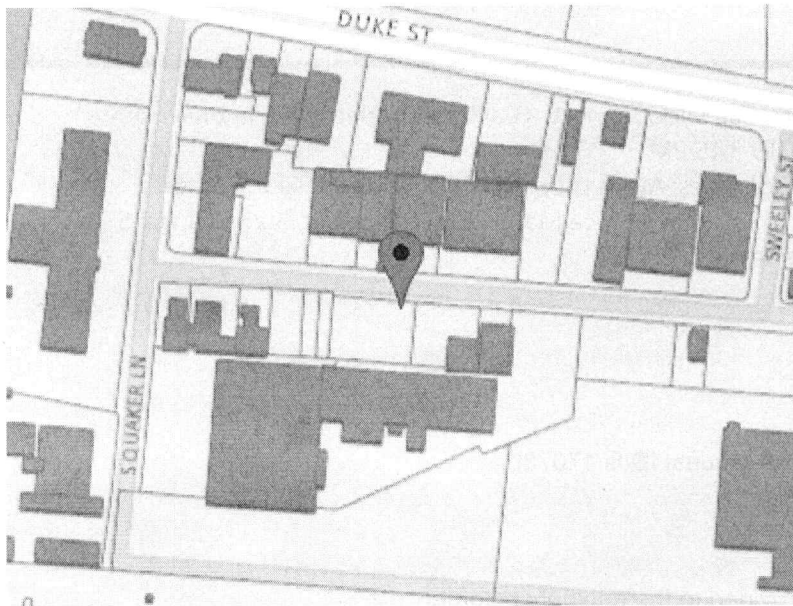

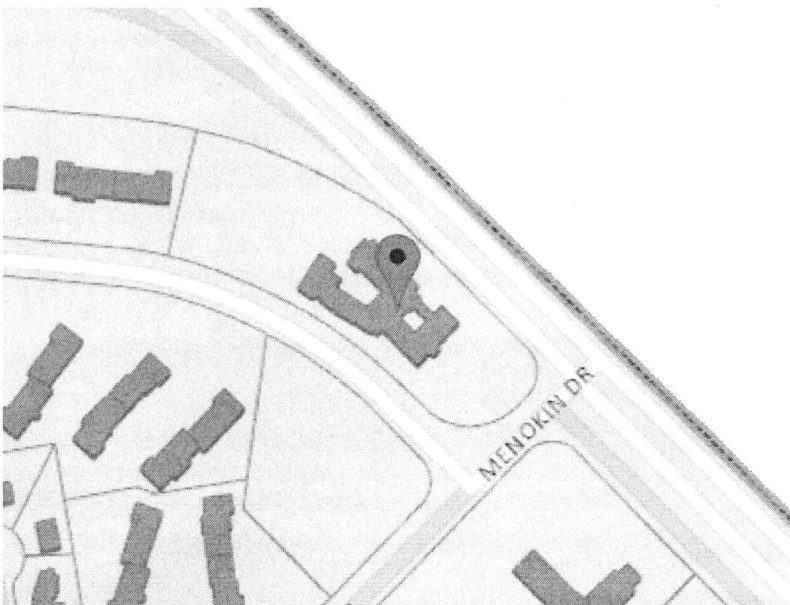

Dear Mayors and City Council Members:

I am writing to you respectfully to urge you not to grant a special permit for a chicken slaughter operation at 3225 Colvin Street in Alexandria.

Despite the Saba Live Poultry business staff's assertion that all the trash and garbage will be stored indoors at all times, this business will truck live birds to the facility. There will be birds crowded in cages in what is most likely to be a putrid smelling interior, as is typical of all the live poultry markets I personally have visited in New York City and that have been visited and recorded by others. These places are filled with birds who typically come from suppliers who round them up from various locations and often these birds are sick and dying with undiagnosed (and of course untreated) illnesses. But even if they are healthy, they must sit in their cages and listen all day long to the cries and screams of the other birds who are having their throats cut.

Please understand that throat-cutting of a living creature including a chicken is NOT humane and that the language of "humane" to describe this process cheapens the word "humane" and falsifies the experience the birds are enduring. This includes the painful, terrifying experience of a knife blade close to the face and cutting into the sensitive skin and trachea and other parts of the innervated face, throat and neck area. It includes the cruelty of making birds awaiting their own deaths listen to the killing being conducted over and over. So forget "humane."

Live poultry markets are not clean places regardless of how much rhetoric is expended to say that they are. The smell of blood and suffering is strong, and most frequently, the birds do not have fresh clean food or water in their cages, adding to the inhumanness of these places which always includes rough handling.

And what happens to the birds who are not slaughtered and sold to customers? How are they disposed of along with the daily mess of entrails, blood and other body parts of birds who are slaughtered? And where do the birds come from to begin with? Where do they originate? How long before their arrival at the killing facility were they deprived of food and water?

I am speaking for the birds and for those residents who justifiably do not want a chicken/poultry slaughterhouse in

their neighborhood. The industrialized poultry industry is 100 percent cruel, filthy, and inhumane, but so are these live poultry operations, which are simply extensions of factory farming rather than "alternatives."

Please reject the proposal that a bird-killing operation be established in Alexandria. Thank you for your attention. I will be happy to speak with you further upon your request.





**ISSUE:** Following the release of the memo related to SUP #2018-0117 for 3225 Colvin Street and sent to City Council on March 21, staff wishes to provide additional information on the following topics:

- Frequency and type of inspections (staff's information has changed since our previous memo)
- Acceptance of waste by AlexRenew
- Control of Odors
- Correction to City Charter Citation

### **DISCUSSION:**

#### ***(A) VDACS Licensing requirements and number of inspections:***

- Staff has received definitive clarification on the licensing requirements after further consultation with the Virginia Department of Agriculture and Consumer Services (VDACS) on the number and frequency of inspection:
  - i. Division of Meat and Poultry:
    - Because the facility would be selling directly to consumers (not wholesale to companies and organizations) it would be eligible for an exemption, so it would not be required to have an onsite inspector even if chicken production exceeds 20,000 per year.
    - The facility would receive a minimum yearly inspection by this division in order to validate sanitary conditions and health of the poultry.
    - The applicant would be required to submit receipts, invoices, and all documentation of sale/purchase in order to validate this exclusion for another year.

**ii. Division of Veterinary Services**

- Facility would be required to undergo a quarterly inspection (closure of the facility for 24 hours) to inspect the cleanliness of the facility, health and fitness of the chickens, and verify shot records. The facility could not reopen until they received a passing grade from this division.

***(B) Acceptance of waste by AlexRenew***

- Based on conversations with AlexRenew representatives, AlexRenew facilities are designed to accommodate commercial and domestic flows.
- Based on a review of the information provided within the staff report and all supplemental materials, the wastewater from this applicant can be properly handled under the existing capacity.
- AlexRenew would further analyze the need for regulatory approval of discharge if the amount of wastewater exceeds 25,000 gallons daily. (See Attachment 1)

***(C) Control of Odors***

- Condition 13 empowers the city to regulate the control of odors, smoke, and any other air pollution from leaving the property or becoming a nuisance. This condition provides the city, as determined by the Director of Transportation and Environmental Services with the flexibility to develop the methods the applicant shall follow to mitigate odors, such as:
  - Requiring the doors and windows of the business to be remain closed at all times.
  - Mandating the submission of a plan for odor control equipment with manufacture specifications prior to submission a building permit for review.
- Although staff believes Condition 13 already allows staff to require doors and windows to be closed and to require the applicant to submit a plan for odor control equipment, City Council could amend Condition 13 to plainly state those requirements as sub-bullets in Condition 13.

***(D) City Charter Provisions***

- The memo dated March 21 makes reference to a City Charter provision that empowers the city with the ability to regulate slaughterhouses. The referenced section number was listed in error, and the correct section number is Section 2.04(m) of the City Charter. (See Attachment 2)

This email is in response to your request regarding the capabilities of the AlexRenew system to accommodate particular types and quantities of wastewater.

The AlexRenew facilities are designed to accommodate commercial and domestic flows. Based on a review of the staff report on line, the wastewater anticipated from this applicant does not appear to pose a potential impact to AlexRenew's treatment processes, nor cause interference or pass through. EPA has no requirements for pretreatment standards applicable for new or existing meat and poultry products (40CFR432). Should AlexRenew be notified that effluent flows from the applicant are anticipated to exceed 25,000 gallons daily, AlexRenew would examine further the need for regulatory oversight of the discharge based on flow.

## **Attachment 2: City Charter Section 2.04(m)**

### **Sec. 2.04 - Power to make regulations for the preservation of the safety, health, peace, good order, comfort, convenience, morals and welfare of the city and its inhabitants.**

In addition to the powers granted by other sections of this charter the city shall have power to adopt ordinances, not in conflict with this charter or prohibited by the general laws of the Commonwealth, for the preservation of the safety, health, peace, good order, comfort, convenience, morals and welfare of its inhabitants. Among such powers, but not in limitation thereof, the city shall have power:

...

- (m) To compel the removal of weeds from private and public property and snow from sidewalks; to compel the covering or removal of offensive, unwholesome, unsanitary or unhealthful substances allowed to accumulate in or on any place or premises; to require the filling in to the street level of the portion of any lot adjacent to a street where the difference in level between the lot and the street constitutes a danger to life and limb; to compel the raising or draining of grounds subject to be covered by stagnant water; to require the razing or repair of all unsafe, dangerous or unsanitary public or private buildings, walls or structures which constitute a menace to the health and safety of the occupants thereof or the public; to require the repair of any damaged, defective or deteriorated condition of dwellings or dwelling units when such condition adversely affects the health or safety of the occupants or the general public; to compel the abatement of smoke and dust and the elimination of unnecessary noise; to regulate or prevent slaughterhouses or other offensive business within the city; to regulate the transportation of articles through the streets; to provide means for and to regulate the cleaning of all dry closets and to assess against the owner or occupant of the premises where same is located a reasonable charge therefor, which shall be collected as other city taxes; and to compel the abatement or removal of any and all other nuisances whatsoever within the city or upon property owned by the city beyond its limits. This memo is to provide information on the State requirements for regulation and inspection of Poultry Slaughterhouses and any associated public health impacts.

### Regulation:

In conjunction with the USDA, the Virginia Department of Agriculture and Consumer Services (VDACS) is the regulating authority for the slaughter of poultry within the State of Virginia. How a slaughterhouse is regulated depends significantly on the number of birds slaughtered and the ownership of the birds. Alexandria Health Department has made numerous calls to VDACS to determine how such a facility would be regulated in the City of Alexandria. From the information provided by the applicant, it is VDACS's belief that the facility would qualify for an exemption from bird-by-bird inspection due to the number of birds that the applicant proposes to process.

An exempt facility is inspected upon opening and then periodically to ensure ongoing compliance with sanitation requirements. On discussion with VDACS there is no set time frame for these inspections, but it would be anticipated that they would be annual or biennially in nature.

The number of birds processed is self-reported by the slaughterhouse, and the slaughterhouse is responsible for ensuring that they do not process more than the 20,000 birds allowed annually.

If they fail to qualify for a bird-by-bird inspection exemption, VDACS stated that there would be an inspector monitoring the plant during all hours of operation to conduct a bird-by-bird inspections. The cost of this inspection was not provided by the VDACS representative spoken to, as they were located in a different locality.

We understand, from the applicant, that the chickens are raised on their farm outside of Virginia. Virginia State requires that all poultry entering into Virginia must be tested negative for Pullorum-typhoid within 30 days prior to entry or be a participant of the National Poultry Improvement Plan (NPPI). Additionally, adult poultry as in this case, must also be tested negative for Avian Influenza within 14 days of movement into Virginia, regardless of NPPI status. Additional import requirements exist including the need to obtain import approval and Veterinary Inspection.

**Public Health Concerns:**

The Alexandria Health Department has consulted with the State's Public Health Veterinarian. Based on the information provided by the applicant and the regulations regarding the movement of poultry from out of state, the Public Health Veterinarian could identify no public health concerns to residents or their pets from the approval of the chicken slaughterhouse.

This letter concerns DC Poultry Market Corporation's Special Use Permit #2018-0117 to operate a retail shopping establishment and a butchery with live poultry, located at 3225 Colvin Street, presented at March 16, 2019's City Council Public Hearing.

I live in the neighborhood of Quaker Village located at Duke Street and Quaker Lane. Quaker Village neighborhood represents 59 homes, over 150 residents, and is located .240 mile (a one-minute drive; 422 yards) away from 3225 Colvin Street, Alexandria, VA.

I present the following for consideration:

- 1) Reject the requested location of 3225 Colvin Street.
- 2) Consider the Eisenhower Avenue Industrial Complex for DC Poultry Market's Alexandria location.

- 1) Reject the requested location of 3225 Colvin Street

I appreciate the desire for the business. I object to the requested location of 6225 Colvin Street for the following reasons:

- a) The proposed location at 6225 Colvin does not seem compatible with the City of Alexandria's long-term economic plans.

6225 Colvin Street sits tightly centered in a bustling commercial district. DC Poultry Market Corporation's slaughterhouse and butcher shop is not similar to the many food-based and animal care small businesses located in the Colvin Street development area.

Colvin Street's onsite and street parking already supports a bevy of city, business, and personal vehicles. The Dash Transportation Center, City of Alexandria Recycling Center, City of Alexandria Street Maintenance, and City of Alexandria School buses also use Colvin Street as well as the adjacent South Quaker Lane and Roth Streets to get to their business locations.

According to the City of Alexandria's Complete Streets Design Guidelines,

"Streets represent the largest public resource by area in Alexandria. Their design and function should enhance the public realm and create multi-functional places that attract people and commerce. "

Approving DC Poultry Market Corporation's slaughterhouse and butcher shop at 3225 Colvin Street would unduly burden a community of pet comfort and training business, restaurants, bakeries, baseball diamond, skateboard park, auto repair, and health services that already suffer from disproportionate environmental impacts.

b) Visit Alexandria's mission is to generate tourism and meetings that increase revenues and promote the City and its assets.

July 25-28, 2019, Alexandria is hosting the Animal Rights National Conference at the Hilton Alexandria Mark Center Hotel, 5000 Seminary Road. (The conference coordinator is an Alexandria resident.) The conference description, on multiple internet sites, is:

c) Protestors Negative Impact on Property Values

Protestors pitting animal rights against religious freedom in a half-mile radius of the commercial development can have negative impacts on surrounding residential property values. Real estate prices are cyclical and property values depend on quality of life and health factors such as noise pollution, peaceful and safe environment, zoning laws, air quality, and traffic volume.

d) Environmental Effects and Quality of Life

At the City Council meeting on Saturday, March 16, 2019, Mr. Mused stated that trucks will travel both to and from the Alexandria facility each day to deliver birds, and an unknown amount of times, at unknown intervals, to carry waste from the facility. Each of these trips is a direct contributor to air emissions, especially because animals need air to travel. In addition, if growth occurs, then to and from the facility several times per week to deliver larger animals.

In the Washington Business Journal, February 7, 2019, DC Poultry Market Corporation Owner, Abdulsalem Mused said,

"While some Saba locations also sell lambs and goats, the Alexandria location will only offer chickens, due to space constraints and the desire to keep the operation small at first, Mused said.

DC Poultry Market Corporation is a subsidiary of Saba Live Poultry whose website states that they specialize in the sale and slaughter of live animals: chicken, ducks, quail, roosters, Guinea hens, other types of fowl, rabbits,

lamb, veal calves, goats, and sheep.

At the City Council meeting on Saturday, March 16, 2019, Mr. Mused stated it "plans to process 100-300 chickens daily and on holidays up to 500 per day."

Regarding SUP 2018-0117, the DC Poultry Market seeking a Special Use Permit to open a live chicken butchery, we strongly object to the location on Colvin Street for a number of reasons. We support the business opening in a DIFFERENT LOCATION, but NOT on Colvin Street where it would pose health risks to the many pets at pet related businesses on the street. According to the CDC, "Poultry may have Salmonella in their droppings and on their bodies (feathers, feet, and beaks), even when they appear healthy and clean....cats and dogs can get Salmonella and become ill." We bring our pup Hattie to Frolick on Colvin Street at least twice a week, and have brought her to Pinnacle Pet Spa on Colvin as well. On the same block as the proposed butchery are also Dogtopia, and of course the annual Love Your Pet Day festival. This block has become a central location for businesses and activities related to the care of animals - not businesses that would bring harm to them. Dogs have a highly enhanced sense of smell, experiencing much of the world through their noses, and would certainly inhale feces, bacteria, fungus, parasites, and other harmful material left behind from the remains of chicken carcasses and chickens dropped off by slaughter house trucks across the street from Frolick. As much as we love Frolick, we would have to protect our Hattie's health and stop bringing her to her favorite place, or any of the businesses on Colvin Street, if the chicken butchery were to be located there.

A secondary reason that Colvin Street is a poor location choice for the chicken butchery is the existing parking limitations that would be compounded by the delivery trucks dropping off live chickens at the same time as people are bringing their dogs to daycare, grooming and other pet related Colvin Street businesses.

We implore City Council protect the health and safety of our four legged family members, and the several Colvin Street businesses that care for them, by rejecting Colvin Street as a location for the chicken butchery and instead considering a more appropriate location. Please do the right thing and consider the harmful effects this business would have on its neighbors.
