On behalf of the Hume Springs Civic Association, I am writing in support of Running Brooke's proposed renovation of the Four Mile Run Playground.

RunningBrooke chose our little playground in Hume Springs for their first playground renovation. It has made such a difference in the feel of our neighborhood. Previously, the playground was under-utilized and overgrown with high chainlink fence flanking its perimeter. It felt like more like a prison yard than a welcoming space for children and families; unfortunately, it was treated accordingly. Discarded trash, public drinking, and even drug use weren't uncommon occurrences in our pocket park.

RunningBrooke fundraised over \$80,000 and worked with the City and neighbors on design concepts and contractors, and then actually sweated it out on the big volunteer day with us! They were so easy to work with and encouraging that you couldn't help feeling inspired. I think it actually brought the neighborhood closer.

We host our annual National Night Out in the playground every August, it's the one time a year our entire neighborhood comes together. The faded equipment has been replaced, the useless west corner is full of activities for older kids and adults, the beautiful landscaping and low fencing makes the little pocket park feel warm and lived-in. It has been a joy the past three years since the renovation to host our event in the playground and now neighbors are proud of both the event and the pocket park we host it in.

I love walking my dogs past the playground and seeing the tables and benches scattered with parents chatting over their playing children. Parents feel safer in the playground and come out at all hours of the day to let their kids burn off some energy. I even see older kids using the exercise equipment on the Dale Street side of the park! The "fullness" of the park discourages the bad behavior that used to occur there and keeps the park safer.



It's been a wonderful transformation to be a part of. Watching RunningBrooke at work has been a great learning experience on how volunteerism works. Residents are more engaged in our community, as well as the larger City because of it. We hope the City will allow RunningBrooke to work its magic in our neighborhood again and bring additional benefit to the surrounding residents, this time on their Four Mile Run Playground renovation.
