The delegation responded to questions and comments from Council about the session and what they would focus on for the next session.

City Council held a discussion with Alexandria's delegation to the General Assembly on the most recent session.

ORAL REPORTS FROM CITY COUNCIL ON BOARDS, COMMISSIONS AND COMMITTEES

*Northern Virginia Regional Commission (NVRC) (Councilman Chapman)

Councilman Chapman reported NVRC would be holding a 50th Anniversary Meet and Greet later in the month and everyone would be receiving an invitation to the event. Councilman Chapman noted that the executive director of NVRC received his evaluation for the year and he presented his assessment of organization to the Commission. Councilman Chapman also mentioned that there are plans to hold a regional economic director meeting to talk about economic development opportunities for the region.

*Patrick Henry Advisory Board Update (Councilwoman Pepper)

Councilwoman Pepper reported the old Patrick Henry Elementary school building would possibly serve as a swing space for Douglas MacArthur Elementary School during construction and there have been meetings to discuss the use and how it would affect the surrounding community. Councilwoman Pepper reported that the School Board voted to use the space as swing space and there will be some planning to configure the old building for use by the fall of 2020.

*Census 2020 Complete Count Committee (Councilman Aguirre)

Councilman Aguirre reported that the Complete Count Committee had the kickoff of the committee with a diverse group and he noted that there are still openings on the Complete Count Committee. Councilman Aguirre noted that is important to get an accurate census count for funding purposes. Councilman Aguirre noted that the Supreme Court would be hearing the cases about the citizen question this month, with a decision by June.

*Local Emergency Planning Committee (Councilman Aguirre and Vice Mayor Bennett-Parker)

Councilman Aguirre reported that this is a board that could benefit from standardization and guidance with their mission. Councilman Aguirre noted that the Committee talked about how they fit into the larger regional picture as it relates to emergency planning and communication.

Vice Mayor Bennett-Parker reported that the boil water advisory received by City residents related to Prince Georges County was in error and there will be some refinement of the process to get the messages to only those affected by the problem.

*Northern Virginia Transportation Commission (Councilman Aguirre and Vice Mayor Bennett-Parker)

Vice Mayor Bennett-Parker reported that the Commission authorized a public comment period for the Commuter Choice projects along I-66 and the comments can be submitted online and in-person at various public hearings. Vice Mayor Bennett-Parker also reported that the Commission approved the selection process and criteria for the I-395 Commuter Choice projects.

Councilman Aguirre noted that the Commission received another update on the upcoming WMATA shutdown.

*Quality of Life Committee (Mayor Wilson and Councilwoman Jackson)

Mayor Wilson reported that the Quality of Life Committee received updates from the Police Department on crime statistics, noting that crime remains low or level. Mayor Wilson reported that there was some discussion on the Drug Treatment court that is being setup and he noted that the City was not successful in getting the grant to start the court. Mayor Wilson stated that there was discussion on how to be successful at getting the grant in the future. Mayor Wilson reported that Code Administration would be holding a building safety event on

April 26 on Market Square. Mayor Wilson reported that the Committee discussed changes to committee and those would be coming to Council for consideration and approval.

ORAL REPORT FROM THE CITY MANAGER

City Manager Jinks reported that the Spring2Action day would be tomorrow on April 10 and they would be working for 24 hours to raise funds for nonprofits in the City of Alexandria.

City Manager Jinks congratulated the Alexandria chapter of the National Forum of Black Public Administrators were named 2018 Small Chapter of the Year at the recent annual forum in Orlando.

Section 3. That the repeal provided for in section 2 of this ordinance shall not affect any offense or act committed or done, or any penalty or forfeiture incurred, or any contract established or accruing prior to the effective date of this ordinance; nor shall it affect any prosecution, suit or proceeding pending or any judgment rendered prior to said date; nor shall it affect any provision of any ordinance amending the Zoning Ordinance which was adopted between October 13, 2018 and December 15, 2018 inclusive, and which is inadvertently omitted from or erroneously incorporated into "The Eighty Fist Supplement to the Zoning Ordinance of the City of Alexandria, Virginia, 1992"; nor shall it affect any ordinance adopted after the effective date of this ordinance.

Section 4. That one complete set of pages comprising "The Eighty Fist Supplement to the Zoning Ordinance of the City of Alexandria, Virginia, 1992," shall be stapled or otherwise permanently fastened together, shall be manually signed on the front sheet by the mayor and the city clerk, and shall be filed in the office of the city clerk and made available to any person desiring to inspect the same. In addition, one complete set of the pages comprising such supplement shall be properly inserted into the copy of the Zoning Ordinance of the City of Alexandria, Virginia, 1992, which bears the manual signatures of the mayor and the city clerk, and such code, as amended and supplemented, shall be kept on file in the office of the city clerk and be made available to any person desiring to inspect the same.

Section 5. That this ordinance shall become effective upon the date and at the time of its final passage.

Section 4. That one complete set of pages comprising "The One Hundred and Thirtieth Supplement to The Code of the City of Alexandria, Virginia, 1981," shall be stapled or otherwise permanently fastened together, shall be manually signed on the front sheet by the mayor and the city clerk, and shall be filed in the office of the city clerk and made available to any person desiring to inspect the same. 31. Virginia American Water Company Rate Case (PUE-2018-00175)

Mr. Eger, Energy Manager, General Services, gave a presentation on the rate case and responded to questions from Council about the proposed rate change.

WHEREUPON, upon motion by Councilwoman Pepper, seconded by Councilwoman Chapman and carried unanimously, City Council: (1) indicated to the State Corporation Commission (SCC) the City's opposition to Virginia American Water Company's (VAWC) proposed 15.84% overall increase in revenue requirement over a 3-year period and resulting rate increases, including the proposed 10.8% Rate of Return on Common Equity; (2) advocated for a more gradual introduction of consolidated revenue requirements and application of single tariff across all districts to lessen the sharp increase in rates proposed to be borne by customers in the Alexandria District; (3) asked staff to continue to investigate the benefits and trade-off of selling the City's fire hydrants to VAWC; and (4) opposed VAWC's proposal to establish the Water and Wastewater Infrastructure Service Charge (WWISC) as a permanent program until the authorized pilot is complete and undergoes thorough and thoughtful cost and benefit evaluation by the SCC. - 1. Change Washington Street HOV lanes from HOV 2 to HOV 3.
- 2. Extend northbound Washington Street HOV lane hours to 6 am to 10 am from the current 7 am to 9 am.
- 3. Extend southbound Washington Street HOV lane hours to 3 pm to 7 pm from the current 4 pm to 6 pm.
- 4. Change East and West Abingdon Drive high occupancy vehicle lanes from HOV 2 to HOV 3.
- 5. Extend northbound East Abingdon Drive HOV lane hours to 6 am to 10 am from the current 7 am to 9 am.
- 6. Extend southbound West Abingdon Drive HOV lane hours to 3 pm to 7 pm from the current 4 pm to 6 pm.

WHEREAS, the City is empowered by Charter Section 2.03 (a) to establish and maintain streets, including limited access or express highways; and

WHEREAS, the City is empowered by City Code Section 10-3-2 to establish hours and occupancy requirements for commuter lanes;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA

- 1. That for the Washington Street commuter lanes bounded by Church St. to the south and Second St. to the north:
 - a. for lanes in which traffic moves in a northerly direction, commuter lane restrictions shall be in effect from 6:00 a.m. to 10:00 a.m.;
 - b. for lanes in which traffic moves in a southerly direction, commuter lane restrictions shall be in effect from 3:00 p.m. to 7:00 p.m.;
 - c. at least three persons must occupy a vehicle in order for it to constitute a high occupancy vehicle and thus be entitled to travel in the commuter lane when the lane's restrictions are in effect.
- 2. That for the East Abington Drive commuter lanes bounded by Second St. to the south and the George Washington Parkway to the north:
 - a. for lanes in which traffic moves in a northerly direction, commuter lane restrictions shall be in effect from 6:00 a.m. to 10:00 a.m.;
 - b. at least three persons must occupy a vehicle in order for it to constitute a high occupancy vehicle and thus be entitled to travel in the commuter lane when the lane's restrictions are in effect.
- 3. That for the West Abington Drive commuter lanes bounded by Second St. to the south and the George Washington Parkway to the north:
 - a. for lanes in which traffic moves in a southerly direction, commuter lane restrictions shall be in effect from 3:00 p.m. to 7:00 p.m.;
 - at least three persons must occupy a vehicle in order for it to constitute a high occupancy vehicle and thus be entitled to travel in the commuter lane when the lane's restrictions are in effect.
- 4. That the City Clerk be, and hereby is, authorized and directed to affix the seal of the City to such documents as may be necessary or convenient implement this Resolution; and
- 5. That the commuter lane restrictions enacted by this Resolution shall be in effect between May 20 and no later than September 30 of 2019.

- 9. Councilman Aguirre reported that there are two more opportunities to receive free tax services at 2525 Mount Vernon Avenue on Wednesday, 6pm -8 pm and Saturday, 9am -12 Noon.
- 10. Councilman Chapman reported that he attended St. Stephens and St. Agnes' First Annual Social Entrepreneurship Summit last Friday and he noted that more than 80 business owners worked with students from around the area and help students work with their entrepreneurial ideas and see how they could positively affect the community.
- 11. Councilman Seifeldein reported that he would be introducing a resolution at the next meeting regarding the Environmental Protection Agency's (EPA) proposal to revise the definition of waters of the United States and was seeking support from his colleagues for the resolution.
