- Request Description: • Increased traffic and consequences of trucks bringing in live animals (businesses and customers have already expressed concern that traffic is really challenging in that neighborhood).
  - Reports that while the initial plan is for chickens, other animals may be trucked in as well
  - Dealing with feces, body parts, trash removal, smell, noise from the chickens, health concerns (not just Salmonella and Campylobacter but respiratory diseases known to stem from inhalation of air with concentrated bird populations).
  - Large air flow exhausts due to sealed, windowless building, and consequence to passersby (perceived or actual)
  - Animal related businesses nearby that would be impacted- e.g. dog walking/pet care nearby and concern by customers about health issues will have them take their business elsewhere
  - A reduction in other customers that oppose the slaughterhouse or no longer feel comfortable frequenting the neighborhood
  - Potential for rodents, as documented in other cases where bird seed is stored
  - Difficulty in addressing such problems once the business is allowed to begin operation and potential negative consequences to the new business owner given the public opposition
  - Negative publicity and portrayal of Alexandria as a city that does not have concern for its residents and business owners

These arguments have nothing to do with respecting the religion or customs of an ethnic group. In fact, I also come from a religious and ethnic minority. These are practical concerns and the value of a democracy is that citizens can express their concerns, especially when the zoning rules do not permit such an operation. While other animal related businesses may allow animals to stay overnight- e.g. pet-care, animal hospitals, etc. – chickens and other farm or wild animals are a different matter. Most ordinances do not allow chickens and other farm animals to be raised within city limits.

There are many opportunities to have a slaughterhouse closer to rural areas where animals are raised. Please consider this recommendation.

Dear Mayors and City Council Members:

I am writing to you respectfully to urge you not to grant a special permit for a chicken slaughter operation at 3225 Colvin Street in Alexandria.

Despite the Saba Live Poultry business staff's assertion that all the trash and garbage will be stored indoors at all times, this business will truck live birds to the facility. There will be birds crowded in cages in what is most likely to be a putrid smelling interior, as is typical of all the live poultry markets I personally have visited in New York City and that have been visited and recorded by others. These places are filled with birds who typically come from suppliers who round them up from various locations and often these birds are sick and dying with undiagnosed (and of course untreated) illnesses. But even if they are healthy, they must sit in their cages and listen all day long to the cries and screams of the other birds who are having their throats cut.

Please understand that throat-cutting of a living creature including a chicken is NOT humane and that the language of "humane" to describe this process cheapens the word "humane" and falsifies the experience the birds are enduring. This includes the painful, terrifying experience of a knife blade close to the face and cutting into the sensitive skin and trachea and other parts of the innervated face, throat and neck area. It includes the cruelty of making birds awaiting their own deaths listen to the killing being conducted over and over. So forget "humane."

Live poultry markets are not clean places regardless of how much rhetoric is expended to say that they are. The smell of blood and suffering is strong, and most frequently, the birds do not have fresh clean food or water in their cages, adding to the inhumanness of these places which always includes rough handling.

And what happens to the birds who are not slaughtered and sold to customers? How are they disposed of along with the daily mess of entrails, blood and other body parts of birds who are slaughtered? And where do the birds come from to begin with? Where do they originate? How long before their arrival at the killing facility were they deprived of food and water?

I am speaking for the birds and for those residents who justifiably do not want a chicken/poultry slaughterhouse in their neighborhood. The industrialized poultry industry is 100 percent cruel, filthy, and inhumane, but so are these live poultry operations, which are simply extensions of factory farming rather than "alternatives."

Please reject the proposal that a bird-killing operation be established in Alexandria. Thank you for your attention. I will be happy to speak with you further upon your request.

I am a resident of the city of Alexandria and the owner of the commercial property and the business fibre space that is located at 1319 Prince Street. I am writing today to urge you to pass the proposal halal butcher at 3225 Colvin Street. This business fits perfectly in an industrial zone. Its neighbors are all industrial uses, and there are no residences anywhere near this location. I personally board my dogs at Dogtopia and see absolutely not impact on their business with this proposed business nearby. In addition, if we don't allow industrial uses in industrial zones, what exactly are we hoping will locate there? As a business owner, I am appalled that another business would object to this use in this zone. It is interesting that she chose to locate her business a few steps away from the city's toxic waste disposal facility but is concerned with the mental impact of livestock being so close to dogs. As a business community, we can not pick and choose who operates in our business districts based on our personal preferences. In addition, the last time our business community and city came out to object to a legally operating business simply because it didn't "jive" with all our perceived "morals," we made the national news. And it wasn't for a good reason. It turned out that the once outraged neighbors of Le Tache now appreciate the additional foot traffic that a vibrant and lively retail establishment has brought to their block. Lets not be on the national news for objecting to a Muslim owned business providing fresh and amazing meat to not only their own community, but the rest of us who might want a better option for poultry. If you eat meat, it arrives to a butcher in a cage and is slaughtered. That is a reality. And while some of our city's residents prefer to ignore that reality when buying it wrapped in plastic from Whole Foods, this shouldn't stop a legal, highly regulated and much needed business from operating in a location specifically zoned for this sort of business.

It is worth reminding everyone that chickens are actually legal in the city of Alexandria as free roaming residents, provided that they are 200 feet from a residence. I imagine that those living on upper King St haven't had to get rid of their dogs due to the mental trauma of chickens on the nearby property. The assertion that a dog boarding facility will be impacted by a butcher is rather ridiculous. And it really shouldn't matter because this business can legally operate in that location. The staff of our city support their SUP and the planning commission passed this unanimously. Please pass this SUP application.
