Hello Ms Mayor, Mr Vice-Mayor and Council Members - I have reviewed the upcoming Docket item relating to the Recommendation from the City Council Naming Committee to Combine the Interim King Street Park. I note that the Naming Committee states: "The members recognized that many in the community supported naming the park after Col. Fitzgerald but spoke to the difficulty of reconciling his extensive contributions to America and Alexandria with his ownership of enslaved persons. The members also recognized that most survey respondents preferred a variety of other names for the new park. "This rationale raises two issue in my mind:

- 1) The reference to slave ownership as criteria for naming public property. Is this a City policy? If so, is there an initiative to change the names of existing City property with names of Founding Fathers that were slave holders, such as Madison, Jefferson, Washington, Franklin, Henry and Lee? If this is not a City policy, why is that criteria being applied in this case?
- 2)The online survey shows 1443 respondents. Of those that had a name suggestion (1219 out of the 1443), 56% preferred Fitzgerald Park (or some derivation including the Fitzgerald name). So, it seems clear that the preference as shown in this survey is Fitzgerald. The question then is, why is the City asking for public input if it is not going to be a factor in the decision?
