  the Tier II Special Tax District. It was unfairly placed on this very small area before there were residents here to
  protest it and other neighborhoods in very similar circumstances (like Potomac Greens) were able to become
  exempted, even though they benefit just as much from the station build.

Some might argue that we agreed to the district when we bought our homes, and we did. But we were not informed at that time that other neighborhoods had later been exempted from the district - putting our homes at a tax disadvantage (and therefore property value disadvantage) to these other very similar homes nearby. I could imagine supporting this tax if all homes benefitting from the metro were also paying it, but as currently written that is not the case.

And then of course there is the fact that the metro station entrance that actually serves the homes in the tax district was deleted, and then that fact hidden from residents by the city, in the summer of 2017. That fact should be the final nail in the coffin for this Tier II tax district. The addition of a ramp is a partial solution. The re-addition of the original south mezzanine would be a much better one. However the final build ends up, for over two years, we have lived under the shadow of this tax and the knowledge (sometimes unknown to us, but known to the city) that despite it, the close metro access we had been promised (and promised to pay for) wasn't actually coming.

This neighborhood welcomes development and transit, and we are thrilled at the work Alexandria has done to bring the VT campus to Oakville triangle. We look forward to moving past the tax district and metro entrance issues, and to our neighborhood serving as a poster child for the kind of mixed-use, walkable, transit-oriented development that Alexandria believes in.


