19 20	(2) The possession, carrying, storage or transportation of firearms by City employees, agents or volunteers in workplaces owned, operated or managed by the City is prohibited.

23	their official duties, (b) sworn law enforcement officers, and (c) private security
24 25	personnel hired by the City, when any of them are present in buildings owned, leased or
25 26	operated by the City or in parks and in any recreational or community facility on any other property that is surred or used by the City (d) historical respectives and any other
