1. Calling the Roll.

Mayor Wilson called the meeting to order and the City Clerk called the roll. All the members of Council were present.

2. Closed Meeting.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Vice Mayor Bennett-Parker and carried 5-0, City Council convened in closed executive session at 6:03 p.m. to consult with legal counsel and staff regarding the disposition of publicly held real property where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body and to discuss reports or plans related to the security of any governmental facility, building or structure, or the safety of persons using such facility, building or structure and any other safety information subject to the exclusion for public safety records where discussion in an open meeting would jeopardize the safety of any person or the security of any facility, building, structure, information technology system, or software program; specifically, the terms and conditions of a contract for sale of four publicly owned parcels in the City, a potential offer to purchase a portion of a publicly owned parcel in the City and a briefing by the Policy Department regarding City Hall security pursuant to Sections 2.2-3711(A)(3) and (A)(19) of the Code of Virginia. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Bennett-Parker, Councilman Aguirre, Councilman Chapman, and Councilwoman Pepper. Absent, Councilwoman Jackson and Councilman Seifeldein.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously, City Council reconvened in open session at 7:15 p.m. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Bennett-Parker, Councilman Aguirre, Councilman Chapman, Councilwoman Jackson, Councilwoman Pepper, and Councilman Seifeldein; Opposed, none.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously, City Council adopted the resolution regarding the closed executive session previously circulated to Council. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Bennett-Parker, Councilman Aguirre, Councilman Chapman, Councilwoman Jackson, Councilwoman Pepper, and Councilman Seifeldein; Opposed, none.

City Council observed a moment of silence and recited the pledge of allegiance.

The vote was as follows: In favor, Mayor Wilson, Vice Mayor Bennett-Parker, Councilman Aguirre, Councilman Chapman, Councilwoman Jackson, Councilwoman Pepper, and Councilman Seifeldein; Opposed, none.

WHEREUPON, upon motion by Councilwoman Pepper, seconded by Vice Mayor Bennett-Parker and carried unanimously, City Council deferred approval of the special public hearing meeting minutes of July 9, 2019. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Bennett-Parker, Councilman Aguirre, Councilman Chapman, Councilwoman Jackson, Councilwoman Pepper, and Councilman Seifeldein; Opposed, none.

ORAL REPORTS BY MEMBERS OF CITY COUNCIL ON BOARDS, COMMISSIONS, AND COMMITTEES

*Council of Governments (COG) Board of Directors (Mayor Wilson)

Mayor Wilson reported that over the summer the COG Board of Directors focused on housing with the goal to get the jurisdictions to expand housing creation for the regional and for residents of moderate and low income levels. Mayor Wilson reported that the Planning Director from Minneapolis, where they recently reformed single family zoning and other zoning. Mayor Wilson noted that there was significant discussion about commitment to housing creation, with consensus that something needs to occur and there is still discussion about the role each jurisdiction will play in the creation. Mayor Wilson pointed out that at the next meeting, members will be asked to commit to 3 target goals, including 320,000 housing units added to the region between 2020 and 2030, at least 75% of housing should be in activity centers or near high capacity transit and at least 75% of housing Director Helen McIlvaine has been instrumental in this process. There was questions from members of Council about the funding issues and other challenges that the region faces with addressing housing issues in the region.

*Northern Virginia Regional Commission (NVRC)(Vice Mayor Bennett-Parker and Councilman Chapman)

Vice Mayor Bennett-Parker reported that the Commission received a presentation on philanthropy throughout the region from the Community Foundation for Northern Virginia at its June meeting and they discussed local jurisdictions as compared to the Commonwealth as a whole and with the nation. Vice Mayor Bennett-Parker reported that the Commission approved the 2020 Budget, which did not include capital dues increase and new officers were elected at the meeting.

Councilman Chapman reported that in July the regional economic development executives came and had a roundtable discussion with the Commission about the need for another economic development body for the region. Councilman Chapman noted that the conversation highlighted how well Alexandria and Arlington work together and the discussion noted that the synergy could foster relationships regionally.

*Northern Virginia Transportation Commission (NVTC)(Vice Mayor Bennett-Parker and Councilman Aguirre)

Vice Mayor Bennett-Parker reported that in July the Commission authorized the executive director to enter into a number of post-shutdown marketing agreements to bring ridership back to Metro. Vice Mayor Bennett-Parker also reported that the Commission authorized public comment on the I-395 Commuter Choice Programs and the public hearing was held last week and both of the Alexandria projects scored well in the process.

Councilman Aguirre reported that another jurisdiction inquired how the shutdown was handled in the City of Alexandria as others with experience the work as Metro continues its upgrading work throughout the region. Councilman Aguirre noted that there was a discussion about fare evasion on WMATA and he would like to continue the discussion around decriminalization of fare evasion in Northern Virginia,

*Virginia Railway Express (VRE) (Vice Mayor Bennett-Parker)

Vice Mayor Bennett-Parker noted that the average VRE ridership was higher than normal over the summer, likely due to the WMATA shutdown. Vice Mayor Bennett-Parker reported that on-time performance continued to improve over the months of April and May and there was a 100% on-time performance day. Vice Mayor Bennett-Parker reported that there will be an upcoming discussion for next year's budget with no fare increase planned as part of that discussion.

*Alexandria Campaign on Adolescent Pregnancy (ACAP) (Vice Mayor Bennett- Parker and Councilman Aguirre)

Vice Mayor Bennett-Parker reported that the student peer leaders organized and ran the Youth Leadership Summit for high school students and she noted that the event included a networking event that she and other members of Council attended.

*Local Emergency Planning Committee (Vice Mayor Bennett-Parker and Councilman Aguirre)

Vice Mayor Bennett-Parker reported that September is National Preparedness Month and there is information on the City's website about how to be prepared in case of an emergency. Vice Bennett-Parker reported that the Health Department will be conducting a flu exercise on October 19 from 10 a.m. to 2 p.m., providing flu shots, hepatitis A vaccines, and HIV testing. Vice Mayor Bennett-Parker reported that the Committee received a presentation from Dominion Virginia Power about their responses during power outages.

*Citizen Corps Council (Councilman Seifeldein and Councilwoman Jackson)

Councilman Seifeldein reported that the Council discussion the flooding event and he noted that they will be introducing the FEMA You Are the Help Until Help Arrives program and begin teaching it throughout the City. Councilman Seifeldein also reported that there has been a lengthy discussion about creating a Citywide resiliency charter that would help establish the City as a leader in the area of preparedness and they would like to work with many other groups and City departments. Councilman Seifeldein reported that the Council has requested that Council allow them to draft the Resiliency Alex Charter by 2020.

*Patrick Henry/Douglas McArthur Community Swing Space Meeting (Councilwoman Pepper and Councilwoman Jackson)

Councilwoman Pepper reported that on August 8 there was community meeting and a meeting of the collaboration group to discuss the use of the old Patrick Henry site once Douglas McArthur began renovation. Councilwoman Pepper noted that the discussion was about the use of the combined site and how it will impact the surrounding community, including traffic, parking and safety evacuations.

Councilwoman Jackson reported that all of the impacted schools' administrations have been involved in the meeting. Councilwoman Jackson reported that drop-off of students and parking will continue to be discussed in order to make the transition smooth. Councilwoman Jackson noted that transportation and scheduling would be worked on in the next few months to ensure a smooth process.

*Alexandria Gang Prevention Task Force (Councilwoman Jackson and Councilman Seifeldein)

Councilwoman Jackson reported that over the summer the 14th Annual regional soccer tournament was held in Arlington County with many Alexandria students represented. Councilwoman Jackson noted that in June the Task Force held their We Are One Tournament and the mentoring programs participated in the tournament as well.

*Alexandria Renew CSO Subcommittee Work Group (Councilwoman Jackson and Mayor Wilson)

Councilwoman Jackson reported that the group went on trip to tour the DC Water to view the tunnel construction in order to compare what Alexandria will need to construct for their outfall facilities. Councilwoman Jackson also noted that the group also tour the area that will be used for Alexandria's outfall facilities.

*Health and Safety Coordinating Committee (Councilwoman Jackson and Mayor Wilson)

Mayor Wilson reported that the Committee reviewed a list of topics for upcoming meeting and the committee will be generating a standard report and the group will begin working on different policy issues at each meeting.

ORAL REPORT FROM THE CITY MANAGER

City Manager Jinks reported on the Wellness Program that has been established for City employees and he gave some of the statistics that have been gathered from participants in the program that was started on July 1. City Manager Jinks noted that 900 or 35% of employees where signed up to participate in the program and he pointed out that employees could earn rewards and cash incentives for participating in the program.

RESOLUTION authorizing the City Manager to execute an agreement to Finalize A BEQUEST FROM Jon H. Rosenbaum, Ph.D. and Betsey R. Rosenbaum TO IMPLEMENT POINT LUMLEY PARK IMPROVEMENTS

WHEREAS, pursuant to Section 2.02 (e) of the Charter of the City of Alexandria (1950), as amended, City Council has the authority to accept gifts and donations; and

WHEREAS, the Waterfront Plan, approved by the City Council in January 21, 2012, is a twenty to thirty year visionary plan for the area extending from Third Street (Tidelock Park) on the north to Wolfe Street (Shipyard/Harborside Park) on the south in the City of Alexandria.; and

WHEREAS, the Phase I landscape and flood mitigation design for implementation of the Waterfront Plan was approved on June 14, 2014 by the City Council; and

WHEREAS, Jon H. Rosenbaum, Ph.D. and Betsey R. Rosenbaum bequest to the City of Alexandria up to \$2.5 million to implement Point Lumley Park improvements consistent with the Waterfront Small Area Plan; and

NOW, THEREFORE, BE IT RESOLVED THAT CITY COUNCIL OF THE CITY OF ALEXANDRIA VIRGINIA HEREBY:

- 1. Accepts the bequest from Jon H. Rosenbaum, Ph.D. and Betsey R. Rosenbaum to implement Point Lumley Park improvements consistent with the Waterfront Small Area Plan; and
- 2. Authorizes the City Manager to execute an agreement and if necessary other documents, to finalize the bequest from Jon H. Rosenbaum, Ph.D. and Betsey R. Rosenbaum to implement Point Lumley Park improvements consistent with the Waterfront Small Area Plan.

WHEREUPON, upon motion by Councilwoman Pepper, seconded by Vice Mayor Bennett-Parker and carried unanimously, City Council passed the ordinance on first reading and scheduled it for public hearing, second reading and final passage on Saturday, September 14, 2019. WHEREUPON, upon motion by Councilwoman Pepper, seconded by Vice Mayor Bennett-Parker and carried unanimously, City Council passed the ordinance on first reading and scheduled it for public hearing, second reading and final passage on Saturday, September 14, 2019. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Bennett-Parker, Councilman Aguirre, Councilman Chapman, Councilwoman Jackson, Councilwoman Pepper, and Councilman Seifeldein; Opposed, none.

ORAL REPORTS AND ORAL PRESENTATIONS BY MEMBERS OF CITY COUNCIL

(a) Council Orals: Consideration of a Resolution Renaming the Second Monday of October Indigenous Peoples' Day. [ROLL-CALL VOTE] (A copy of the City Manager's memorandum dated September 4, 2019, is on file in the Office of the City Clerk and Clerk of Council, marked Exhibit No. 1 of Oral Reports and Oral Presentations; 09/10/19, and is incorporated as part of this record by reference.)

Council Orals: Consideration of a Resolution Renaming the Second Monday of October Indigenous Peoples' Day.

Councilman Seifeldein thanked all who worked on the proposed memorandum and resolution to rename the second Monday of October Indigenous Peoples' Day. Councilman Seifeldein also recognized members of the Native American community, particularly Opal Boyer, a member of Yavapi-Apache Nation and a program specialist with the Administration for Native Americans, who were present and who assisted him with research for the resolution.

WHEREUPON, upon motion by Councilman Seifeldein, seconded by Vice Mayor Bennett-Parker and carried unanimously by roll-call vote, City Council adopted a resolution proposed by Councilman Seifeldein and Vice Mayor Bennett-Parker to rename the second Monday of October Indigenous Peoples' Day. The vote was a follows: In favor, Mayor Wilson, Vice Mayor Bennett-Parke, Councilman Aguirre, Councilman Chapman, Councilwoman Jackson, Councilwoman Pepper, and Councilman Seifeldein; Opposed, none.

The resolution reads as follows:

RESOLUTION NO. 2899

Recognizing the Second Monday of October as Indigenous Peoples' Day

WHEREAS, the City of Alexandria recognizes that Indigenous Peoples of the lands that would later become known as the Americas have occupied these lands since time immemorial; and

WHEREAS, Indigenous Peoples' Day was first proposed in 1977 by a delegation of Native Nations to the United Nations-sponsored International Conference on the Discrimination Against Indigenous Populations in the Americas; and

WHEREAS, the Commonwealth of Virginia is home to Indigenous Peoples and the Commonwealth of Virginia currently recognizes 11 Indigenous tribes; and

WHEREAS, Indigenous Peoples' unique and valuable legacy has largely been treated as a footnote in history. In Virginia schools, Indigenous history is taught insofar as it relates to the eventual European colonization; and

WHEREAS, 50,000 Indigenous Peoples comprised at least 15 separate Nations prior to the arrival of English settlers in Virginia. These include the Doege Indian village, which was cited on John Smith's 1608 map, and the Nottoway, Mattaponi, Nansemond, Pamunkey, Manahoac, Tutelo, Patawomeck, Sappony, Shawnee, Occaneechi, Meherrin, Paspahegh, Appommatoc, Chisca, and Westo; and

WHEREAS, the Namaengbquend Tribe is believed to be the indigenous owners of present-day Alexandria. The tribes that inhabited Northern Virginia and the area that is now the City of Alexandria were parts of, or allies with, the powerful Powhatan Confederacy. Many Indigenous People were displaced from their homelands and driven onto reservations as the English, and later, American colonial settlers, pushed to occupy more land in the region. Many of the Indigenous Peoples' in Virginia had been subjugated, killed, or removed by the turn of the 18th century; and

WHEREAS, as of January 2018, there are only seven federally recognized nations in Virginia—they are the Pamunkey Indian Tribe, Chickahominy, Eastern Chickahominy, Rappahannock, Upper Mattaponi, Nansemond, and Monacan tribes. There remain three State recognized Tribes: Cheroenhaka (Nottoway), Nottaway Tribe and the Patawomeck Tribe; and

WHEREAS, the City recognizes that Indigenous People have been and continue to be the victims of prejudice and systematic discrimination, which perpetuates high rates of income inequality and exacerbates disproportionate health, education, and social standing. The City has a duty to oppose such discrimination, promote opportunity for those of Indigenous descent, and foster a welcoming, inclusive, equitable, and just community for all; and

WHEREAS, recognizing Indigenous Peoples' Day would be a crucial first step in acknowledging the deliberate and systematic oppression of Indigenous People, to celebrate their resiliency and contributions while acknowledging the current presence of Native Nations and their thriving cultures, while also sharing current issues facing their communities; and

WHEREAS, since 1994, more than 130 cities across the country have renamed Columbus Day as Indigenous Peoples' Day; and

WHEREAS, the renaming of the holiday would not have an impact on the existing federal or City holiday and will still occur on the second Monday in October; and

THEREFORE BE IT RESOLVED, that the City Council of the City of Alexandria does hereby proclaim that the second Monday of each October shall perpetually be known and celebrated as Indigenous Peoples' Day;

BE IT FURTHER RESOLVED, the City recognizes and values the vast contributions made to our community and our country through Indigenous Peoples' knowledge, science, governance, philosophy, arts, and culture;

BE IT FURTHER RESOLVED, that the City of Alexandria strongly encourages Alexandria's State representatives to vigorously introduce legislation to recognize Indigenous Peoples' Day on the second Monday of each October instead of the day before Thanksgiving;

BE IT FURTHER RESOLVED, that the City of Alexandria affirms that it is the City's policy to participate in the annual Indigenous Peoples' Day celebrations and that City departments work with the Indigenous People, the Alexandria Office of Human Rights and the Alexandria Human Rights Commission to encourage participation on a citywide basis;

BE IT FURTHER RESOLVED, that the City of Alexandria strongly encourages Alexandria City Public Schools to include the teaching of Indigenous Peoples' history with contemporary context and celebrate Indigenous Peoples' Day on the aforementioned time;

BE IT FURTHER RESOLVED, that the City of Alexandria encourages other businesses, organizations, and public institutions to recognize Indigenous Peoples' Day in a meaningful way and in partnership with local Native Nations;

BE IT FURTHER RESOLVED, that the City of Alexandria calls on all sports organization operating in the Commonwealth of Virginia to cease the heinous use of Indigenous Peoples' liken as mascots; and

BE IT FINALLY RESOLVED, that the City of Alexandria firmly commits to continue its efforts to promote the well-being and growth of the City's Indigenous Community and Indigenous Peoples' Day.

1. Councilwoman Jackson reported that she attended the Friendship Firehouse Festival to celebrate the first fire company in Alexandria.

2. Councilwoman Jackson reported that she attended the Crime Commission hearing in Richmond and read the letter from the City Council before the Commission regarding gun safety legislation.

3. Councilwoman Jackson reported that she attended the Governor's Pre-K Stakeholder Listening Tour in early August to discuss funding for Pre-K educational programs in Northern Virginia.

4. Councilwoman Jackson reported that the attended the recognition ceremony for the 80 Anniversary of the Library Sit-In at the Queen Street library.

5. Councilwoman Jackson reported that she attended the Irish Festival and the owner of O'Connell's, John Brennan, will be the grand marshal at the St. Patrick's Day parade.

6. Councilwoman Jackson reported that she attended the inaugural Emerging Writers Festival at the Athenaeum sponsored by Old Town Books. Councilwoman Jackson noted that the City's poet laureate participated in the event.

7. Councilwoman Jackson reported that she and Councilman Seifeldein attended Judge Rossie Alston's investiture to the Federal Court at the Bryan Federal Courthouse.

8. Councilwoman Jackson recognized the Friends of Guest House on reaching their 45th Anniversary and opening of a second location to assist women reentering society following incarceration.

9. Councilwoman Jackson welcomed all the students in the City of Alexandria back to

school and wished them a successful school year.

10. Councilman Aguirre recognized the staff at VRE for his ride on the train and for sharing information with him about VRE.

11. Councilman Aguirre stated that he, along with Deputy City Manager Baker and other City staff, went to Richmond and received approval for the first part of the permit from the Department of Environmental Quality for the Potomac Yard Metrorail Station.

12. Councilman Aguirre reported that he attended the grand opening of the Play Garden at the Mount Vernon Community School last week.

13. Councilman Aguirre reported that the attended the Africa Festival on Saturday at the Patrick Henry School.

14. Councilman Aguirre thanked staff for putting up a Frequently Asked Questions list on the DCHS website about public charge to provide additional information and he would like to work with surrounding jurisdictions to create a unified message for the region about public charge.

15. Councilman Aguirre would like to explore the option of providing full benefits (health benefits) to Council aides and would like more information from staff about the issue.

16. Councilman Aguirre requested that a proclamation be added to the next legislative docket recognizing Latino Heritage Month, which is September 15 through October 15.

17. Councilman Aguirre thanked his colleagues for approving an extra \$50,000 for the Complete Count Committee and he invited everyone to attend the meeting tomorrow at Cora Kelley Elementary School.

18. Councilman Seifeldein recognized Councilman Chapman for winning the bowling tournament sponsored by the NAACP for its Back to School celebration.

19. Councilman Seifeldein recognized his nephew's soccer team, Alexandria Soccer, for winning state championship during the summer and advancing to the regional competition.
