3 4	An Ordinance to amend and reordain subsection (l) (Agudas Achim Congregation Election District) of Section 2-2-10 (Establishment of Election Districts and Voting Places), and to amend
5	and reordain "The Official Map of the City of Alexandria, Virginia, Designating Election
6	Districts and Voting Places," adopted by Section 2-2-13 (Map of Election Districts and Polling
7	Places), all of Chapter 2 (Elections), Title 2 (General Government) of The Code of the City of
8	Alexandria, Virginia, 1981, as amended to rename the Agudas Achim Congregation Election
9	District the Charles Barrett Center Election District and establish the Charles Barrett Center (in
10	lieu of Agudas Achim Synagogue) as the polling place for this precinct for elections in 2020 and
11	thereafter.
12	
13	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
14	
15	Section 1. That Subsection (d) of Section 2-2-10 of The Code of the City of Alexandria,
16	Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to delete the
17	text shown in strikethrough and add the text shown in underline as follows:
18	
19	(I) The Agudas Achim Congregation Charles Barrett Center Election District shall be
20 21	bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district. The voting place within the Agudas Achim Congregation
22	<u>Charles Barrett Center Election District shall be at the Agudas Achim Congregation, located at</u>
23	2908 Valley Drive Charles Barrett Center located at 1115 Martha Custis Drive.
24	2700 Valley Drive charles Barrett Center located at 1113 Wartha Custis Drive.
25	Section 2. That "The Official Map of the City of Alexandria, Virginia, Designating
26	Election Districts and Voting Places," adopted by Section 2-2-13 of the Code of the City of
27	Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained as
28	shown on Exhibit 1, attached hereto and incorporated fully by reference, to reflect the
29	designation and description of: the Charles Barrett Center Election District, in replacement of the
30	of the Agudas Achim Congregation Election District.
31	
32	Section 3. That the general registrar of voters be, and she hereby is, directed to record the
33	foregoing amendments on the said map.
34	
35	Section 4. That this ordinance shall become effective upon the date and at the time
36	of its final passage and the adjustments contained herein will be utilized for the elections in 2020
37	and thereafter until or unless further modified and amended.
