- WHEREAS, with 14 years of experience in architecture and historic preservation, and a Master's Degree in Urban Design and Preservation, Al Cox joined the City of Alexandria as a registered Architect in September of 1991 serving in the capacity of Urban Planner II for the Department of Planning & Zoning assigned to the Board of Architectural Review and to the City's two Historic Districts; and
- **WHEREAS**, during his time with the City of Alexandria, Al Cox rose through the ranks of Urban Planner to Urban Designer to City Architect; and, over the past ten years, to City Architect and Historic Preservation Manager; and
