# Recommendation

- Receive staff's recommendation to proceed with Modified Idea #1 for enhanced southwest access and docket for Public Hearing on April 18, 2020
- Approve Modifications to the WMATA Funding Agreement
- Authorize WMATA to issue change order to PYC to design and construct Modified Idea #1 for enhanced southwest access

## **Consideration of Enhanced Southwest Access**

- City Council directed staff to refine options for enhanced access
- WMATA gave direction to PYC to provide cost estimate
- City and WMATA prepared independent cost analysis for the options
- WMATA/City conducted multiple negotiation meetings structured around the major areas of estimate discrepancies
- All parties came to agreement in principle for fee for Modified Idea #1
- WMATA, City, and DRPT agreed that the fee was fair and reasonable
- Total cost, including WMATA and City cost will be within \$50 million State funding along with the credit for the original ramp
- Schedule will allow completion with the station.

## **PYMIG Feedback**

 Staff presented a recommendation to PYMIG based on the established objective

The objective is to enhance the Potomac Yard Metro southwest station entrance by maximizing accessibility, promoting walkability, and increasing economic potential for the Potomac Yard area.

• PYMIG members discussed options with their constituents and provided individual feedback




