

**AMENDMENT TO TELECOMMUNICATIONS FACILITY LICENSE  
AGREEMENT BETWEEN THE CITY OF ALEXANDRIA AND  
NEW CINGULAR WIRELESS PCS, LLC.**

This Amendment to Telecommunications Facility License Agreement (“Amendment”) is made this \_\_\_\_ day of June, 2020, to the Telecommunications Facility License Agreement (“Agreement”) between the City of Alexandria, Virginia, a municipal corporation of the Commonwealth of Virginia (“City”), and Cellco Partnership, a Delaware general partnership, d/b/a Verizon Wireless (“Verizon”), dated October \_\_, 2019.

**RECITALS**

WHEREAS, under the Agreement the City has granted Verizon the authority to install “Approved Equipment,” as defined in the Agreement, on “Approved Poles,” as defined in the Agreement, within the City’s Public Rights-of-Way;

WHEREAS, Verizon has subsequently requested and the City has agreed to approve additional locations for Verizon to install Approved Equipment on additional existing wooden poles located within the City’s Public Rights-of-Way;

WHEREAS, Verizon has also subsequently requested and the City has agreed to approve one additional location for Verizon to install Approved Equipment on a single metal pole to be located within the City’s Public Rights-of-Way;

WHEREAS, the City and Verizon seek by this Amendment to add to the Agreement additional Approved Poles as set forth on new Exhibit A-4, which will be incorporated into the Agreement;

NOW, THEREFORE, in consideration of the mutual promises stated below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Verizon, intending to be bound, agree as follows:

**AMENDMENT**

1. Section 1.3 of the Agreement is hereby amended to read as follows:

1.3 “Approved Pole”:

“Approved Pole” means (i) an existing wooden pole for which either (a) all required permits have been granted by the City as of June 1, 2020; or (b) complete applications for all required permits have been received by the City by June 1, 2020; and (ii) a single metal pole for which all required permits have been granted by the City as of June 1, 2020. All Approved Poles are listed at Exhibits A and A-4.

2. Exhibit A-4 is hereby deemed attached to and part of the Agreement.
3. The remaining terms and conditions of the Agreement shall remain in full force and effect.

**IN WITNESS WHEREOF**, the parties hereto have executed this Amendment to the Telecommunications Facility License Agreement.
