4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
5	adopting and incorporating therein the amendment heretofore approved by city council to
6	the Potomac Yard/Potomac Greens Small Area Plan chapter of such master plan as Master
7	Plan Amendment No. 2020-00001 and no other amendments, and to repeal all provisions of
8	the said master plan as may be inconsistent with such amendment.
9	
10	WHEREAS, the City Council of the City of Alexandria finds and determines that:
11	
12	1. In Master Plan Amendment No. 2020-00001, the Planning Commission, having
13	found that the public necessity, convenience, general welfare and good zoning practice so
14	require, recommended approval to the City Council on June 2, 2020 of an amendment to the
15	Potomac Yard/Potomac Greens Small Area Plan Chapter of the Master Plan of the City of
16	Alexandria to amend a principle in the "CDD Guidelines for Potomac Yard/Potomac Greens" to
17	change references of Home for the Elderly to Continuum of Care Facility and to increase the
18	number of these types of dwelling units from 150 to 190, which recommendation was approved
19	by the City Council at public hearing on June 20, 2020;
20	
21	2. The said amendment has heretofore been approved by the planning commission
22	and city council after full opportunity for comment and public hearing.
23	
24	3. All requirements of law precedent to the adoption of this ordinance have been
25	complied with; now, therefore,
26	
27	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
28	
29	Section 1. That the Potomac Yard/Potomac Greens Small Area Plan Chapter of the
30	Master Plan of the City of Alexandria, be, and the same hereby is, amended by amending item
31	#1e of the "CDD Guidelines for Potomac Yard / Potomac Greens" on Page 71 to state "325,000
32	net square feet, maximum amount of Continuum of Care Facility space, which may include up to
33	190 dwelling units."
34	
35	Section 2. That the director of planning and zoning be, and hereby is, directed to
36	record the foregoing master plan amendment as part of the Master Plan of the City of
37	Alexandria, Virginia.

39	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,
40	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.
41	
42	Section 4. That the Master Plan of the City of Alexandria, as amended by this
43	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,
44	Virginia.

Section 5. That the city clerk shall transmit a duly certified copy of this ordinance to the Clerk of the Circuit Court of the City of Alexandria, Virginia, and that the said Clerk of the Circuit Court shall file same among the court records. Section 6.
