On August 29, 2020, Mr. Crane retired from federal civil service. From 2005 to 2020, Mr. Crane served as the Position, Navigation and Timing (PNT) Resilience Advisor to the Office of Chief Information Officer of the U.S. Department of Homeland Security. Mr. Crane was responsible for coordinating and aligning national policy on space, the U.S. Global Positioning System (GPS), complementary PNT capabilities, and civil use of time and location-based services, technologies, applications and data with the geospatial intelligence, information sharing, infrastructure protection, space, cybersecurity, and resilience strategies of the Department. Assignment included serving as the senior homeland security advisor/liaison to the Space-Based PNT Executive Committee, co-chaired by the Deputy Secretaries of Transportation and Defense, and the interagency National Coordination Office, located at the Department of Commerce. Previous assignments included deputy director of the DHS national security systems program, advisor to the U. S. Coast Guard and the DHS on the maritime information sharing environment, and Commander in the Coast Guard Reserve. Commander Crane held a number of active duty senior officer positions in the marine transportation system, maritime homeland defense, readiness and contingency planning, and workforce management prior to his retirement in 2004 after 26 years of military service. Mr. Crane has private sector experience in transportation, financial services, oil & gas, and agriculture sectors. Mr. Crane holds a B.S., a M.B.A., business continuity credentials through the Disaster Recovery Institute International, and membership in the Institute of Navigation, International Association of Emergency Managers, the Association of Contingency Planners, and Reserve Officers Association.
