I've been serving on this board for the last two years where we have created a vision and strategic plan for the board, I would like to continue to serve on the board to assist in following through with the vision and plan. Equal justice and criminal justice reform have been among the issues I've been advocating for as an activist. I grew up in a country where unlike the United States there was no rule of law; there was no such thing as judicial independence. Police and law enforcement was nothing but an arm of the state's regime to suppress dissent and crack down on opposition. The outcome of your encounter with the so called law all depended solely on who you know and how much money you had. Such an unfair system creates nothing but contempt for the law and a feeling that safety and justice do not exist. These experiences created in me the need to fight for justice and those suffering from injustice as I can relate to what they are going through, the feeling of injustice is such a terrible thing. Also these experiences make me appreciate and value living in a society that respects and follows the rule of law, where I know I will be treated fairly and feel safe. Being grateful for living in a safe rule of law society and having my rights respected, it's my obligation to work for those who don't may be suffering from injustice in this community, fight to advance causes of justice and equity, and to preserve and advance the values that are the bed rock of this system. Over the past four years, I've been a grassroots activist and a member of the Alexandria democratic committee where I organize, advocate, research, write, and volunteer in political campaigns within and outside Alexandria city. I've advocated for police data transparency, and been working with several organizations advocating with ACPS to implement a robust restorative practices program to break school to prison pipeline. I believe our criminal justice system can further improve so that everyone has a fair shot at it. We need to find better ways to deal with minor crimes, petty offenses, and addictions by implementing programs that tackle the root causes rather than implementing punitive measures. I'm always looking to engage our community and bring the challenges we face to our city government and the board, and to work collectively towards plans and visions that further improve our criminal justice system.
