11	Section 1. That Section 2-4-100 of the Code of the City of Alexandria, Virginia,			
12	1981, as amended, be, and the same hereby is, amended by deleting the text shown in			
13	strikethrough and adding the text shown in underline as follows:

15 16	Sec. 2-4-100 - Creation, composition and organization.			
10	(a) There is hereby established a board to be known as the Alexandria Community Criminal			
18	Justice Board.

20	(b) The board shall consist of 19 members to be appointed by the city council. The composition			
20 21	of the board shall be as follows:			
21	(1) one judge of the Alexandria general district court;			
23	(2) one judge of the Alexandria circuit court;			
23 24	(3) one judge of the Alexandria juvenile and domestic relations court;			
25	(4) the chief magistrate for the city;			
26	(5) the chief of police;			
27	(6) the sheriff; (7) the commonwealth's attenness			
28	(7) the commonwealth's attorney; (8) the administrator of the situ's community complete heard.			
29	(8) the administrator of the city's community services board;

38	(c) Members of the board shall be appointed in the manner prescribed by article A of this			
39	chapter; provided, that:			
40	(1) the member who is a local educator shall be nominated by the superintendent of schools and			
41	confirmed by city council;			
42	(2) the member who is a representative of the business community shall be recommended by the			
43	Alexandria Chamber of Commerce; and			
44	(3) the member who is a representative of non-profit organizations shall be recommended by the			
45	Alexandria United Way; and			

1	(4)(3) all members of the board, except for the citizen members, shall be exempt from the			
2 3	application requirement set forth in section 2-4-7(c) of this code.			
4 5 6	(d) The citizen members and the member who is a local educator shall serve for a term of two years, except in the case of an appointment to fill the unexpired portion of a term.			
7 8 9	(e) Any officer of the court appointed to the board may designate a member of his staff approved by city council to represent him or her at meetings of the board.
