I'm not sure if there is anything I need to do.

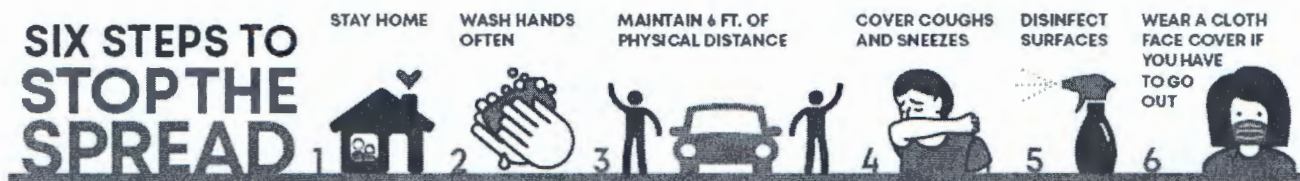
I don't know if we have a meeting before then. Please let me know.
