I have been the Chair of the IT Commission for the last 2 years and a member since 2013 (for 7 years). This pandemic has driven home the issue our IT Csn has been focused on since I joined -- the critical necessity for everyone in our community to have access to modern broadband in order to participate in modern life. I would like to continue to lead our Commission's efforts in this arena: our short-term effort to ensure every student has access to modern broadband during and after this pandemic, and for the long-term, our effort to support the deployment of our city's municipal fiber backbone (and spare conduit) to all public buildings and schools. This project will not only save costs and ensure gigabit access for our public institutions, but will serve a carrot to attract new gigabit providers to bring fiber to every home and business. (If your home is served with fiber, its value increases 3%, and if Gigabit is flowing over that fiber, your home value increases up to 8%. MDU owners can also rent at 5% higher if they can offer gigabit connectivity). It will also provide our community an enormous tool to ensure digital equality. It was Alexandria's small businesses who originally asked for internet choice in our community. The future of our economy now depends on it. I would like to serve Alexandria by continuing to lead our IT Commission and City efforts toward that goal.
