Dear Committee Members, Thank you for considering my application for membership on the Alexandria-Caen Sister City Committee. I am very interested in the position. I first learned of the Alexandria-Caen Sister Committee when reading a flyer about the summer internship program. Having just returned to Alexandria from a year in Paris I thought about how many French students I've met who would love such an opportunity for a professional experience in the United States and vice versa for American students in France. That is what led me to seeking out the committee and its efforts to exchange between the two cities. As mentioned, my children and I have recently returned to Alexandria from Paris this summer where we were living for the past school year. Before moving to Alexandria in January 2019 we resided in New Orleans, LA, where we lived for six years and we were active in the francophone community through our children's French bilingual school. While living in New Orleans I worked in fundraising for The National World War II Museum and traveled to this area fairly often meeting with veterans and donors. After some years with The Museum I opened my French import store, Petit Paris Market. I traveled to France twice a year meeting with the owners of small companies that produced confiserie and epicerie following in the artisanal French regional traditions. Because my grandfather was from Pau I have been interested in my French roots since childhood. Through my business and our children's schools I have enjoyed connecting and building lasting relationships with members of the francophone and French-American communities in New Orleans, Paris and now the DC area. My interest in participating on the committee, therefore, comes from my family Franco-American cultural heritage, knowledge of France and my belief in the Sister City program created by President Eisenhower to advance and support diplomacy, peace and appreciative exchange between cities. I would welcome the opportunity to contribute to these goals through the committee and give back between cultures.
