**ISSUE:** Consideration of a recommendation from the Department of Recreation, Parks and Cultural Activities to change the name of 3550 Commonwealth Avenue Park to Shirley Tyler Park.

**RECOMMENDATION:** That the City Council Naming Commission support the staff recommendation and forward the proposal to rename 3550 Commonwealth Avenue Park to Shirley Tyler Park to City Council for consideration.

**BACKGROUND:** The Department of Recreation, Parks and Cultural Activities (RPCA) received two suggestions for the renaming of 3550 Commonwealth Avenue Park:

- 1. **Shirley Tyler Park**: Mrs. Shirley Tyler was a community leader in Alexandria for more than 40 years. Tyler and her family moved to Arlandria in 1965 where she was a resident until her death in February 2018. They were the first African American homeowners in their neighborhood. Tyler became involved in the Arlandria Civic Association. In 1973, Tyler was appointed to the Alexandria School Board. From 1974 to 1976, she served as vice chair and from 1980 to 1982 served as the first African American female chairperson. She was an educator. From 1969 to 1979, she was a 2<sup>nd</sup> and 3<sup>rd</sup> grade teacher at Grace Episcopal School. In 1975, she became the Headmistress and remained in that position until her retirement in 1989. (Attachment 1)
- 2. **Unity Park**: Unity Park reflects the "hopes and dreams that we have for this park...it would be a place of connection, recreation, and fun for all of the people that live in the

neighborhoods surrounding it. It would also serve as a reminder of where we have come from and where we are going. In addition, the name also speaks to the fact that it sits between several neighborhoods and recognizes all the work the residents of the various surrounding neighborhoods put into the original park construction." (Attachment 2)

<u>DISCUSSION</u>: In response to RPCA receiving requests to rename 3550 Commonwealth Avenue Park (Attachment 3), RPCA issued a community survey asking the community to vote for their preferred name. The survey was open from January 20 to March 14 (55 days). The survey received 456 responses (Attachment 4). The name Shirley Tyler received 82% of the vote or 371 respondents selecting Shirley Tyler as their preferred name.

As a result of the overwhelming support for Shirley Tyler, staff is recommending that 3550 Commonwealth Avenue Park be renamed Shirley Tyler Park.

**FISCAL IMPACT:** The cost to install a new park identification sign and biographical sign, and to replace the existing regulatory signage is approximately \$5,500.

### To Whom It May Concern:

On behalf of the Lynhaven Citizens Association (LCA), I would like to voice our support for naming the neighborhood park located at 3550 Commonwealth Ave, Unity Park. I make this request after a unanimous vote of support was take at a recent general membership meeting.

As you may know, in 1970, 19-year-old Robin Gibson was murdered at the 711 that was located next to the current site of the park. This ignited the racial tensions that had been brewing throughout desegregation.

John L. Hanna, assistant manager of the store, said he observed Gibson putting razor bags into a bag.

"Gibson then allegedly pulled a knife on Hanna. Hanna told police he then pulled a revolver from his right hip pocket and fired once. Gibson staggered toward the door and collapsed."

Immediately after the shooting at 6:35 p.m., a crowd began to gather outside the store. By 9 p.m., approximately 500 to 600 people had gathered outside the store. Violence broke out as persons in the large crowd began hurling rocks.

The crowd spread to other nearby stores, where more rocks were thrown through windows and a fire was ignited. As the night went on, the violence spread throughout Del Rey, more cars destroyed and cars overturned.

Over the next three nights, violence continued across the city: 14 arrests and seven cases of arson.

Hanna was charged with murder that night, but was released on \$10,000 bond shortly afterwards. In mid-June, Hanna admitted he had planted his own knife near the body. After one trial ended in a hung jury, he pled guilty to manslaughter and served less than a year in prison before he was paroled.

Given this history we believe that Unity Park is a fitting name because speaks to hopes and dreams that we have for this park. That it would be a place on connection, recreation, and fun for all of the people that live in the neighborhoods surrounding it. It would also serve as a reminder of where we have come from and where we are going.

In addition, this name also speaks to the fact that it sits between several neighborhoods (Including Lynhaven, Hume Springs, and Del Ray) and recognizes all the work the residents of the various surrounding neighborhoods put in to the original park construction.

In conclusion, please consider approving the name of "Unity Park" for the neighborhood park at 3550 Commonwealth Avenues. Thank you.

The City of Alexandria is soliciting feedback on the name of the park at 3550 Commonwealth Avenue, located on the corner of Commonwealth Avenue and Reed Avenue. The public is invited to participate in an <u>online survey</u> now through March 3, 2020 to provide feedback on two proposed names:

- 1. Unity Park: As stated in the proposal, Unity Park reflects the "hopes and dreams that we have for this park...it would be a place of connection, recreation, and fun for all of the people that live in the neighborhoods surrounding it. It would also serve as a reminder of where we have come from and where we are going. In addition, the name also speaks to the fact that it sits between several neighborhoods and recognizes all the work the residents of the various surrounding neighborhoods put into the original park construction."
- 2. Shirley Tyler Park: The proposal states that for more than 40 years, Mrs. Shirley Tyler was a community leader in Alexandria. Tyler and her family moved to Arlandria in 1965 where she was a resident until her death in February 2018. They were the first African American homeowners in their neighborhood. Tyler became involved in the Arlandria Civic Association. In 1973, Tyler was appointed to the Alexandria School Board. From 1974 to 1976, she served as vice chair and from 1980 to 1982 served as the first African American female chairperson. She was an educator. From 1969 to 1979, she was a 2nd and 3rd grade teacher at Grace Episcopal School. In 1975, she became the Headmistress and remained in that position until her retirement in 1989.

In Fall 2019, City Council adopted a <u>naming policy</u> for the renaming of park and recreation facilities in the City of Alexandria. The objective of this policy is to establish a consistent approach for the official naming or renaming of City public parks, recreation areas, and facilities. The policy allows for a community-driven naming process, stating, "An individual or group submits a name recommendation to the

Director of the Department of Recreation, Parks and Cultural Activities either by mail or online form. The submission must include the justification for the proposed name, including how the name meets the criteria in this policy, at least one letter of recommendation from representatives in the community, such as a community organization (HOA/Civic Association), and an explanation of any additional information on a community outreach process."

Tyler se involucró en la Asociación Cívica de Arlandria. Era activa en la desegregación de las escuelas públicas de Alexandria. En 1973, Tyler fue nombrado miembro de la Junta Escolar de Alexandria. De 1974 a 1976 era vicepresidenta y de 1980 a 1982 fue la primera presidenta afroamericana. Ella era una educadora. De 1969 a 1979, fue maestra de segundo y tercer grado en la Escuela Grace Episcopal. En 1975, se convirtió en directora y permaneció en ese puesto hasta su jubilación en 1989

En el otoño de 2019, el ayuntamiento adoptó una política para nombrar y renombrar los parques y centros de recreación en la ciudad de Alexandria. El objetivo de esta política es establecer un proceso consistente para nombrar o renombrar oficialmente los parques públicos, las áreas de recreación y las instalaciones de la Ciudad.

La política permite <u>un proceso liderado</u> por la comunidad, que establece: "Una persona o grupo presenta una recomendación de nombre al director del Departamento de Recreación, Parques y Actividades Culturales, por correo o la web. La sumisión debe incluir la justificación para el nombre propuesto, incluyendo como el nombre cumple con los criterios de esta política, por lo menos una carta de apoyo de los representantes de la comunidad, como una organización comunitaria (HOA /Asociación Cívica) y una explicación sobre el proceso comunitaria usada".



This is gleaned from her Living Legends tribute in 2014: For more than 40 years, Mrs. Shirley Tyler was a community leader in Alexandria. Tyler and her family (husband, son and daughter) moved to Arlandria, Alexandria in 1965 and she was an Alexandria resident until her death in February 2018. She moved from Edison Street in Hume Springs to Goodwin House in 2014. They were the first African American homeowners in their neighborhood. Tyler became involved in the Arlandria Civic Association because of the problems of: Flooding from Four Mile Run Tyler worked tirelessly to bring about what became the Four Mile Run Flood Control Project by the US Army Corps of Engineers. Rat infestation The group's community efforts at resolving the problems with rats led to city rules requiring trash to be placed in cans with lids. Drug dealing Their efforts at curtailing drug traffic were ongoing and led to the establishment of a satellite police facility in the neighborhood. Housing Also, as part of the Arlandria Citizens Association, she fought the intentional redlining by real estate agents where absentee landlords did not keep their property in good shape or illegally subdivided houses and apartments into multiple units. She was active in the desegregation of Alexandria public schools. She worked closely with Living Legends Ferdinand Day and Lynnwood Campbell and others to assure that her children and all children received a first-class education. In 1973, Tyler was appointed to the Alexandria School Board. From 1974 to 1976, she served as vice chair and from 1980 to 1982 served as the first African American female chairperson.
